ABS NEWS ROUNDUP: PEOPLE, ORGANIZATIONS, AND PROJECTS

THE NATIONAL SCIENCE FOUN-DATION has awarded \$22,790 to Southern Methodist University for A SUMMER CONFERENCE ON THE APPLI-CATIONS OF MATHEMATICS IN POLITICAL SCIENCE for college teachers of political science. The Foundation grant covers the living, travel, and tuition expenses of each participant. Interested persons should write directly to Professor Joseph L. Bernd, Department of Government, Southern Methodist University, Dallas, Texas. The conference will be limited to 30 persons and will be scheduled to permit participants time for some summer teaching.

In what seems to be a substantial INNOVATION IN THE FIELD OF TEACHER TRAINING, Northwestern University will, in the fall of 1965, abandon its traditional education courses for prospective teachers, offering in their place a new program emphasizing subject matter and presenting the theory, methods, and problems of education in seminars, tutorials, and practice teaching. The new program is to be sponsored by a \$125,000 grant from the Carnegie Corporation of New York.

Endowment for International Peace is sponsoring the work of a Committee on Research Evaluation in the Field of International Relations. The Committee has met three times since December, 1963, and expects to publish its report in 1965.

Professor P. E. Mosely, Director of the European Institute and Associate Dean of the Faculty of International Affairs at Columbia University, is chairman. E. R. Platig of the Endowment will be responsible for the final report. The report is expected to deal with the following topics: international relations as a field for research, the nature and functions of research, forms and procedures for evaluating research, criteria for evaluating research in international relations. The report will also contain the recommendations of the Committee.

THE LIBRARY OF CONGRESS has re-

cently published a new bibliography on Southeast Asia. "Southeast Asia: An Annotated Bibliography of Selected Reference Sources in Western Languages" is 180 pages and is for sale at \$1 per copy at the U.S. Government Printing Office. Prepared by Cecil Hobbs, head of the South Asia Section in the Library's Orientalia Division, the work contains 535 entries, most of which were published between 1952 and 1963. The new publication covers Burma, Thailand, Laos, Cambodia, the Vietnams, Malaysia, Indonesia, and the Phillipines. An elaborate index lists maps, tables, and other components of the works, as well as the usual author-title arrangement.
