ASIAN INSTITUTE OF INTERNATIONAL STUDIES

We are happy to record the activities of the Asian Institute of International Studies as expressed in its first public session held at the University of the Philippines June 14 to June 18, 1866, and also to advise our members of the plans for the second session to be held at the same place in the coming summer June 5th to 30th, and at which the main lecture course will be in charge of Professor Richard Baxter, an old and much respected friend of this Society.

The Institute is a joint project of the College of Law of the University of the Philippines and the Philippine Society of International Law. Its fundamental objective is to promote understanding of the role of law in the effective relations of states and peoples, particularly in Asia. More specifically it aims to increase the capacity of government officers and law practitioners to recognize and deal professionally with interrational law questions, to improve the quality of teaching in international law and relations, and to encourage scientific and creative inquiry. Each session consists of three lecture courses, divided into a main lecture course of eighteen hours and two other courses of ten lecture hours each, together with a number of seminar periods, all being conducted in the English larguage.

At the 1966 session the main course was given by Professor Leo Gross of the Fletcher School of Law and Diplomacy, and the short courses by Professor B.S. Murty of Anchia University, India and Professor Franklin Chi-Chin Yao of the National Taiwan University. The topics of the main course were the Dynanics of International Law examined under the headings of:

- 1. Present State of International Law.
- 2. Expositors of International Law.
 - (a) Governments.
 - (b) Domestic Tribunals.
 - (c) International Organizations.
 - (d) International Tribunals.
- 3. Political and Legal Foundations of a New International Order.
 - (a) Rights and Duties of States. The Supremacy of International law.
 - (b) The Use of Force,
 - (c) Principles Concerning Friendly Relations and Cooperation between States.
 - (d) Peaceful Settlement of International Disputes.
- 4. Socio-Economic Foundations of a New International Order.
- 5. Contemporary Theories of International Law.

The short courses were given on International Adjudication: Present Scope, Prospects and Policy, and International Protection of Human Rights. There was a regular attendance of thirty-four persons and the result appears to have been one of very general appreciation of the value of the experiment. The subject of the courses for the forthcoming session of 1967 have not yet been announced. Attendance from abroad is invited. Those desiring to attend are required to have a college degree with experience in public service in law, foreign service, economics or political science. Applications to the Executive Secretary of the Institute at the University of the Philippines, Quezon City, Philippines, are to be made not later than March 5, 1967. A number of grants to cover travelling expenses and cost of living of qualified prospective foreign visitors were available where such need was satisfactorily shown. A registration fee of 50 pesos is required from each prospective visitor (the appropriate conversion rate is P. 3.90 to U.S. dol. 1.00). No tuition fees, however, will be charged for the second session, the same having been covered by a foundation grant.

We are glad to call to the attention of our members the opportunities offered by the Asian Institute of International Studies and to express the hope that a substantial representation of Egyptian membership will be registered.
