## ABSTRACT

Background checks involve gathering information from state and federal databases to determine if child care providers have a history of child abuse or other criminal convictions that would make them unacceptable for working with children. Background checks include state criminal history checks, state child abuse registry checks, and Federal Bureau of Investigation (FBI) checks. In response to a Congressional request, the Government Accounting Office provided information for each state about the background checks required for its regulated child care providers. The information expands on aggregate data presented on background check requirements in a previous report examining state activities to enforce child care requirements. The data used were collected by a survey sent to child care licensing directors in 50 states and the District of Columbia in May 1999. The correspondence indicates that all but four states require at least one type of check be conducted on their regulated providers, while many states require more than one be conducted. Also shown are which types of background checks are required by each state for regulated family child care homes, group homes, and child care centers. (EV)

Subject: Child Care: State Requirements for Background Checks

This letter responds to your request that we provide information for each state about the background checks it requires to be conducted on its regulated child care providers. This information expands upon the aggregate data presented on background check requirements in our recent report, which examined state activities to enforce child care requirements.<sup>1</sup>

Background checks involve gathering information from state and federal databases to determine if providers have a history of child abuse or other criminal convictions that would make them unacceptable for working with children. As we reported, experts and the literature both identified conducting background checks as one of several critical licensing activities that help states ensure the safety and health of children in child care settings. Background checks on providers include state criminal history checks, state child abuse registry checks, and Federal Bureau of Investigation (FBI) checks. All but four states require that at least one type of check be conducted on their regulated providers, while many states require that more than one be conducted. The enclosure to this letter shows which types of background checks are required by each state for regulated family child care homes, group homes,<sup>2</sup> and child care centers.

The data used in our report and in this correspondence were collected through a survey sent to child care licensing directors in 50 states and the District of Columbia in May 1999; all surveys but one were returned. The survey asked about the extent to which licensing offices conducted critical enforcement activities, including background checks, during fiscal year 1999. We conducted our work for this correspondence between January and February 2000 in accordance with generally accepted government auditing standards.

<sup>2</sup>Typically, family child care consists of one provider caring for six or fewer children in the provider's home. Group home care usually involves two providers caring for 7 to 12 children in a provider's home.


