
LOCAL FLORIDA PUBLIC SCHOOL PROGRAMS FOR EXCEPTIONAL

FIRST TABLE RANKS BY TOTAL NUMBER OF TEACHERS 95 OF THE 100
LARGEST PUBLIC SCHOOL PROGRAMS FOR EXCEPTIONAL CHILDREN IN
THE UNITED STATES. ELEVEN OF THE 95 PROGRAMS ARE IN FLORIDA
COUNTIES. RANKINGS ARE MADE IN SEVEN AREAS OF
EXCEPTIONALITY--(1) SPEECH HANDICAPPED, (2) SPECIAL LEARNING
PROBLEMS, INCLUDING EMOTIONALLY DISTURBED, SOCIALLY
MALADJUSTED AND DELINQUENT, AND LEARNING PROBLEMS,
NEUROLOGICALLY IMPAIRED AND BRAIN DAMAGED, (3) EDUCABLE
MENTALLY HANDICAPPED, (4) TRAINABLE MENTALLY HANDICAPPED, (5)
PHYSICALLY HANDICAPPED, (6) DEAF AND SEVERELY HARD OF
HEARING, AND (7) VISUALLY IMPAIRED, BOTH BLIND AND PARTIALLY

COMPARATIVE SURVEY OF 192 PUBLIC SCHOOL PROGRAMS FOR EXCEPTIONAL CHILDREN

PROGRAMS SURVEYED

A listing of public school systems ranked by size of enrollment for the 1964-65 school year was obtained from the U. S. Office of Education.¹ Eleven of Florida's counties rank in the first 100 largest school systems in the country. No Florida counties rank in the second 100 school systems and seven Florida counties rank in the third 100. Questionnaires were sent to the first and third 100 largest school systems in the country for comparison with Florida's local programs for exceptional children.

The survey was conducted as to the number of children served and the number of public school teachers employed for each of eleven areas of exceptionality and educational and psychological evaluation. The figures for seven of the areas are given in this report. The seven areas are:

1. Speech Handicapped
2. Special Learning Problems (A combination of the data reported for three areas: a) emotionally disturbed, b) learning problems, neurological impaired, brain damages, and c) socially maladjusted and delinquent.)
3. Educable Mentally Retarded
4. Trainable Mentally Retarded
5. Physically Handicapped (not including homebound and hospitalized)
6. Deaf and Severely Hard of Hearing (including only public school Programs)
7. Visually Impaired (blind and partially sighted, including only public school programs)

The tables were constructed from the figures for full time teachers reported by the various local school programs on the questionnaire form or in annual statistical reports which they sent.

T A B L E I

Data was received from 95 of the first 100 largest school systems in the country. These are ranked in Table I by the total school population for 1965-66. The number of full time teachers employed in each of the seven exceptionalities are shown. Shown in parenthesis is the ranking of the number of teachers.

The eleven Florida counties rank in the number of teachers consistently lower than their total school population rank except in programs for the trainable mentally retarded and the physically handicapped.

Table II shows the rankings in the areas of Speech Impaired, Educable Mentally Retarded, and Trainable Mentally Retarded according to a ratio of the number of teachers per 10,000 students of the total school population.

It is interesting to note that in programs for the speech impaired, New York City ranks first in the number of total number of therapist but ranks forty-first in the number of therapists per 10,000 students. Dade County, Florida which is the seventh largest school system ranks seventeenth in the total number of therapist but ranks only seventy-fourth in the number of therapists per 10,000 students.

The seven Florida counties included in this grouping rank twice as many times in the number of total teachers above their population rank than below. It is interesting to note that four of the seven Florida counties rank above their population rank in every area in which they report a program.
