Foreword

Much of the work of the California Junior College Association is accomplished by committees. These committees fall into four classifications:

1. Constitutional Committees
2. Standing Committees
3. Special Committees
4. Articulation Committees

The first group, as the name indicates, are established by the CJCA Constitution, which also prescribes their function, membership composition, and terms of office.

The second and third groups are established by the CJCA Board of Directors, and serve many purposes. Standing Committees deal with matters of continuing interest; members are named for stated terms. Special Committees ordinarily are named for one year only, though they may be extended.

The fourth group are the committees related to the annual Articulation Conference, by means of which are brought together representatives of high schools, junior colleges, the California State Colleges, and the University of California, with the purpose of maintaining maximum understanding among these segments of public education, and of resolving problems of articulation as they arise.

All committee terms end on June 30 of the indicated year. Staggered terms provide continuity on Constitutional and Standing Committees, and on certain of the Articulation Committees.

In the naming of persons to CJCA committees, effort is made to distribute committee service widely over the State among junior college persons, thus avoiding overloading any one individual or member college.

Wherever possible, it is expected that travel costs of committee members attending committee meetings will be borne by their respective districts as a professional responsibility. Where this is not possible, the member's Regional Junior College Association may be able to assume the cost. In still other instances, the CJCA Board of Directors may authorize payment from funds of the Association.

BOARD OF DIRECTORS

A. Function

"The duties of the Board of Directors shall be

- a. To implement policy for CJCA and act on behalf of CJCA.
 - b. To cooperate with the State Department of Education and other public or private agencies concerned with education on the junior college level.
 - c. To propose the annual budget and recommend to CJCA the rate of membership dues.
 - d. To recommend to the President of CJCA the establishment, continuance, or discontinuance of CJCA committees.
 - e. To plan and promote the regular and special meetings of CJCA.
 - f. To appoint or reappoint the Executive Secretary of CJCA and to determine his term of office, salary, and responsibilities.
 - g. To appoint or reappoint the Legislative Advocate of CJCA and determine his term of office, salary, and responsibilities.
 - h. To name a President's Advisory Committee to assist the President in emergencies.
 - i. To act on all applications for membership in CJCA."
- Constitution. Article VI, Section 3

B. Responsibility

To the membership of CJCA.

C. Meetings

Usually mid-summer, mid-fall, mid-winter, and at the time of the state conferences. Also at the call of the President.

D. Membership

"The Board of Directors of CJCA shall consist of the following:

- a. The President and the Vice President of CJCA.
- b. The Immediate Past President of CJCA.
- c. The Presidents of the Regional Associations.
- d. The Immediate Past Presidents of the Regional Associations.
- e. A faculty representative from each of the Regional Associations for a two year term.
- f. The Chairman of the following Constitutional Committees: Athletics, Articulation, Finance and Legislation, Curriculum and Instruction, Guidance and Student Personnel, Continuing Education, Accreditation, and Relations with Organizations Other Than Schools.
- g. Four members of junior college governing boards, to be selected from the Junior College Section of the California Schools Boards Association in accordance with CSBA procedure, for two-year terms with two terms ending each June 30.
- h. A representative of the State Department of Education.
- i. The Legislative Advocate of CJCA.
- j. The Executive Secretary of CJCA.

The representative of the State Department of Education, the Legislative Advocate of CJCA, and the Executive Secretary shall serve without voting privileges."

I. COMMITTEE ON ACCREDITATION

A. Function

"The function of this Committee shall be to serve as representatives of CJCA on the Accrediting Commission for Junior Colleges of the Western Association of Schools and Colleges.

Note: The Accrediting Commission for Junior Colleges is composed of nine persons: five CJCA representatives, two persons named by the Accrediting Commission for Senior Colleges and Universities, one person named by the Accrediting Commission for Secondary Schools, and one person named by the State Department of Education."

--Bylaws. Article II, Section 8 c

B. Responsibility

To the Board of Directors of CJCA and, as part of the Accrediting Commission for Junior Colleges, to the Directors of the Western Association of Schools and Colleges.

C. Meetings

Normally, the Commission will hold two meetings per year.

D. Membership

"This Committee shall be composed of the following:

Five members appointed by the President of CJCA.

The President shall name one of the members to serve as Chairman."

"This Committee shall meet regularly with representatives of the California Association of Secondary School Administrators, the State Colleges of California, and the University of California, to consider and study problems of mutual concern and importance."

CONSTITUTIONAL COMMITTEE

III. COMMITTEE ON ATHLETICS

A. Function

"The function of this Committee shall be

1. To formulate general rules and regulations governing intercollegiate athletics for member institutions, according to policies adopted by CJCA.
2. To determine conditions of intersectional and championship contests and to supervise arrangements for the same."
--Bylaws. Article II, Section 1 c

"Athletic conferences shall have jurisdiction over all athletic regulations within the respective conferences, subject to policies adopted by CJCA and rules established by the Committee on Athletics. Any conflicts which cannot be resolved within the conferences or between conferences shall be referred to the Committee on Athletics for settlement."

"Decisions of the State Athletic Committee shall be final and shall be enforced by suitable penalties."

"Athletic policies of CJCA shall constitute the California Junior College Athletic Code.

- a. Changes in general policies governing athletic relationships among the member colleges and the athletic conferences shall be circulated in advance to member institutions following a 2/3 vote of approval of the Committee on Athletics. Such policies shall be ratified by a 2/3 vote of the member institutions.
- b. Policies may be proposed to the Committee on Athletics
 1. By members of the Committee on Athletics.
 2. By the Board of Directors of CJCA.
 3. By written petition of any athletic conference or regional association.
 4. By written petition of ten (10) member colleges.
- c. All colleges participating in an athletic conference shall be members in good standing of CJCA."

2. Subcommittee on Real Estate Education

A. Function

1. To serve in an advisory capacity to the Real Estate Commissioner's Real Estate Education and Research Advisory Committee (the CREERAC) and to the Committee on Curriculum and Instruction of CJCA.
2. To promote effective junior college courses and curriculum materials in real estate education.
3. To encourage state-wide uniformity in course designation, content, and units of credit earned in real estate education.
4. To assist individual junior colleges with their own real estate education projects.
5. To consider any problems germane to the development of the highest possible level of professional real estate education and to recommend to the Commissioner through the CREERAC, as well as to the CJCA Committee on Curriculum and Instruction, such actions as committee deliberations may suggest.

B. Responsibility

To the Real Estate Commissioner of the State of California through the CREERAC, and to the CJCA through the Committee on Curriculum and Instruction.

C. Meetings

A minimum of two meetings each college year, and at such other times as the Chairman, upon agreement with the Senior Deputy, Education, may issue a call.

D. Membership

1. Nine persons, each of whom is directly involved in the Real Estate Education Program of a junior college in an instructional, supervisory, or administrative capacity.
2. 3. All past Chairmen of the Committee and the junior college representative on the CREERAC shall be designated as ex-officio members.
4. Such consultative members as the Committee may choose to recommend and the Commissioner in agreement with the Executive Secretary of the CJCA, acting with and for the President of said Association, shall approve, may be appointed to attend such meetings or serve on such projects as their potential and assignment may determine.
5. Such Real Estate Coordinators, Deans of Instruction, or other administrative, supervisory, or instructional personnel related to the Junior College Real Estate Educational Program as the Chairman, in consultation with the Commissioner's committee representative, shall determine, may be invited to attend regular or called meetings of the Committee as guest-observers.
