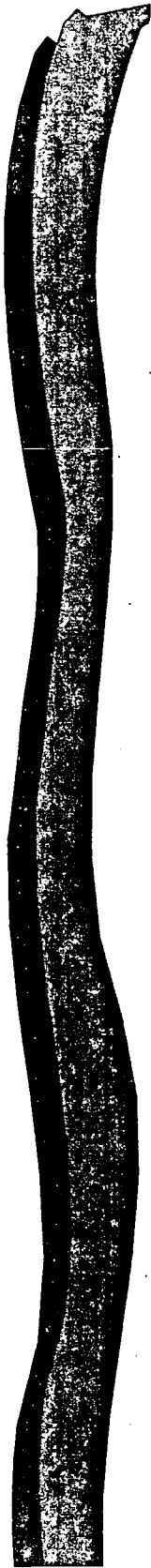

ABSTRACT

The purpose of this report is to provide a snapshot of the Iowa community colleges during fiscal year 1998-1999. It is not designed to provide trend analysis or year-by-year comparative information. All statistical and financial information used in this publication originates at Iowa's community colleges and is reported to the Iowa Department of Education, Bureau of Community Colleges. Highlights include: (1) credit enrollment (unduplicated headcount) of Iowa's 15 community colleges totaled 93,140, ranging from a low of 1,355 to a high of 18,250; (2) credit hours totaled 1,383,233, ranging from a low of 23,715 to a high of 239,582; (3) full-time status as a portion of total students ranged from a low of 43 percent to a high of 72 percent; (4) enrollments in non-credit classes totaled 616,825 (approximately 314,000 unduplicated headcount); (5) approximately 25 percent of expenditures were for vocational-technical programs, and 21 percent for arts and science programs; and (6) a total of 13,279 instructional, administrative, professional, secretarial and clerical, and service personnel were employed. INTRODUCTION AND PURPOSE OF THE IOWA COMMUNITY COLLEGE INFORMATION SYSTEM (MIS) FISCAL YEAR 1998-1999 YEAR-END REPORT

This report serves as a demonstration of the capabilities of the community college Management Information System (MIS), maintained by the Iowa Department of Education. The 15 community colleges electronically submitted the Fiscal Year 1998-1999 year-end enrollment, human resources, and financial information by August 4, 1999. All data in this report, except where noted, are taken from the Iowa Department of Education's Fiscal Year 1998-1999 MIS student enrollment, human resources and financial information electronic data files. Fiscal Year 1998-1999 was the first year of reporting for the non-credit MIS enrollment data.

The purpose of this report is to provide a snapshot of the community colleges during Fiscal Year 1998-1999. This report is not designed to provide trend analysis or year-by-year comparative information. More detailed information may be obtained by contacting the Bureau of Community Colleges at the Department of Education at (515) 281-3125.

All statistical and financial information used in this publication originates at Iowa's community colleges and is reported to the Iowa Department of Education, Bureau of Community Colleges.

This report provides a sampling of the summative data reports that can be generated utilizing the community college Management Information System (MIS). As the Department of Education continues its work with the 15 community colleges in refining the system, additional summative data will be available. For instance, more detailed information will be available through the Human Resources component on community college personnel salaries and length of contracts.

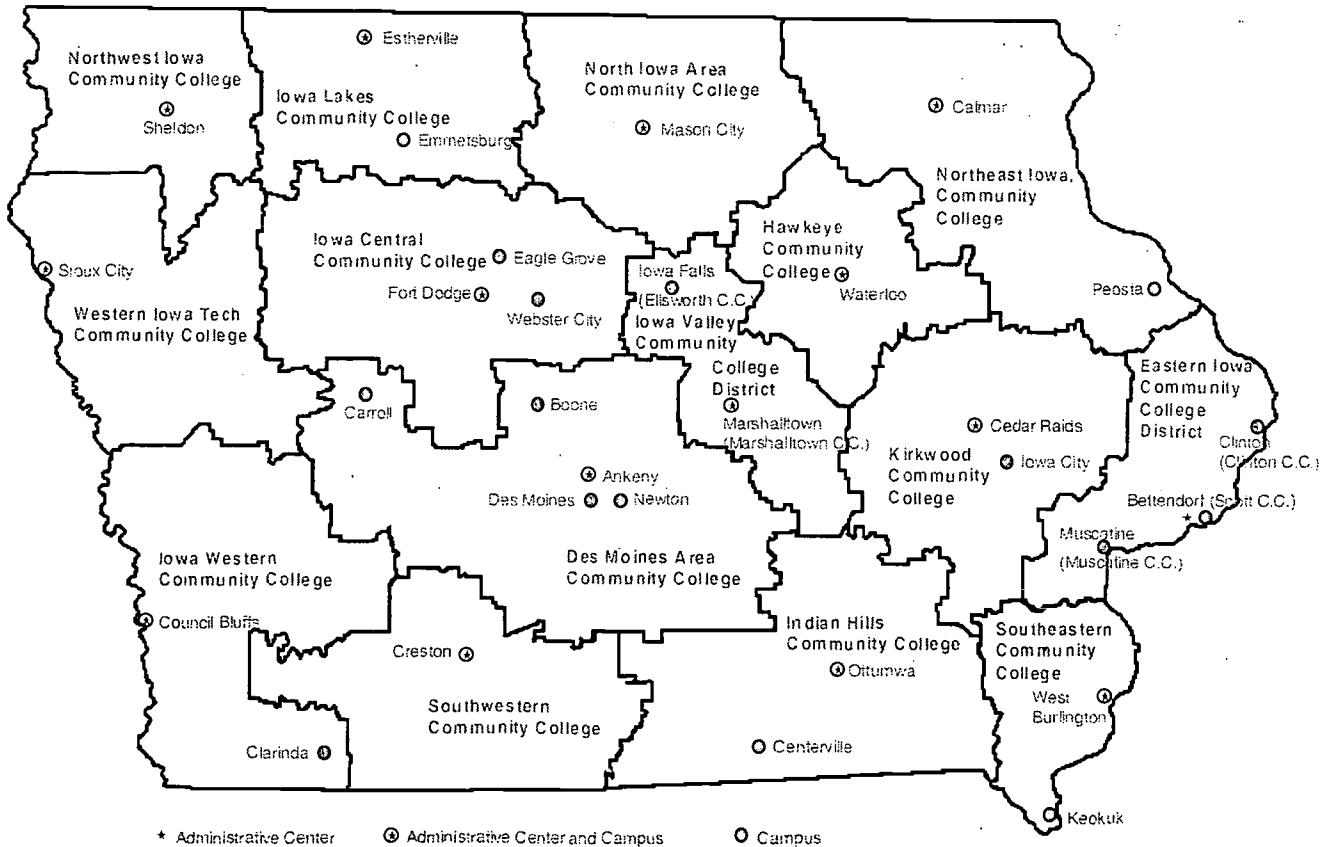



IOWA COMMUNITY COLLEGES MISSION STATEMENT

It is the mission of Iowa community colleges to offer quality programs, courses and services to meet the different community interests, student abilities and personal objectives of citizens of all ages and levels of education for the purpose of improving the quality of life, the economic conditions and the public welfare of our state.

Adopted by the community colleges and included in *A Strategic Planning Philosophy*, 1990.


IOWA COMMUNITY COLLEGES STATEMENT OF PURPOSE

Iowa Code 260C

260C.1 Statement of Policy.

It is hereby declared to be the policy of the state of Iowa and the purpose of this chapter to provide for the establishment of not more than fifteen areas which shall include all of the area of the state and which may operate community colleges offering to the greatest extent possible, educational opportunities and services in each of the following, when applicable, but not necessarily limited to:

1. The first two years of college work including preprofessional education.
2. Vocational and technical training.
3. Programs for in-service training and retraining of workers.
4. Programs for high school completion for students of post-high school age.
5. Programs for all students of high school age, who may best serve themselves by enrolling for vocational and technical training, while also enrolled in a local high school, public or private.
6. Programs for students of high school age to provide advanced college placement courses not taught at a student's high school while the student is also enrolled in the high school.
7. Student personnel services.
8. Community services.
9. Vocational education for persons who have academic, socioeconomic, or other disabilities which prevent succeeding in regular vocational education programs.
10. Training, retraining, and all necessary preparation for productive employment of all citizens.
11. Vocational and technical training for persons who are not enrolled in high school and who have not completed high school.
12. Developmental education for persons who are academically or personally underprepared to succeed in their program of study.

The year-end reporting process is comprised of several components. The Management Information System (MIS) process for confirming Fiscal Year 1998-1999 data submitted by Iowa community colleges includes: edit checks by the department, verification and confirmation of the data by the community colleges, and audits of the data that are completed by the State Auditors or independent audit firms.

Quadrant meetings were held in April 1999 at Estherville, Ankeny, Waterloo and Cedar Rapids. The purpose of these meetings was to review the reporting guidelines and requirements with community college staff.

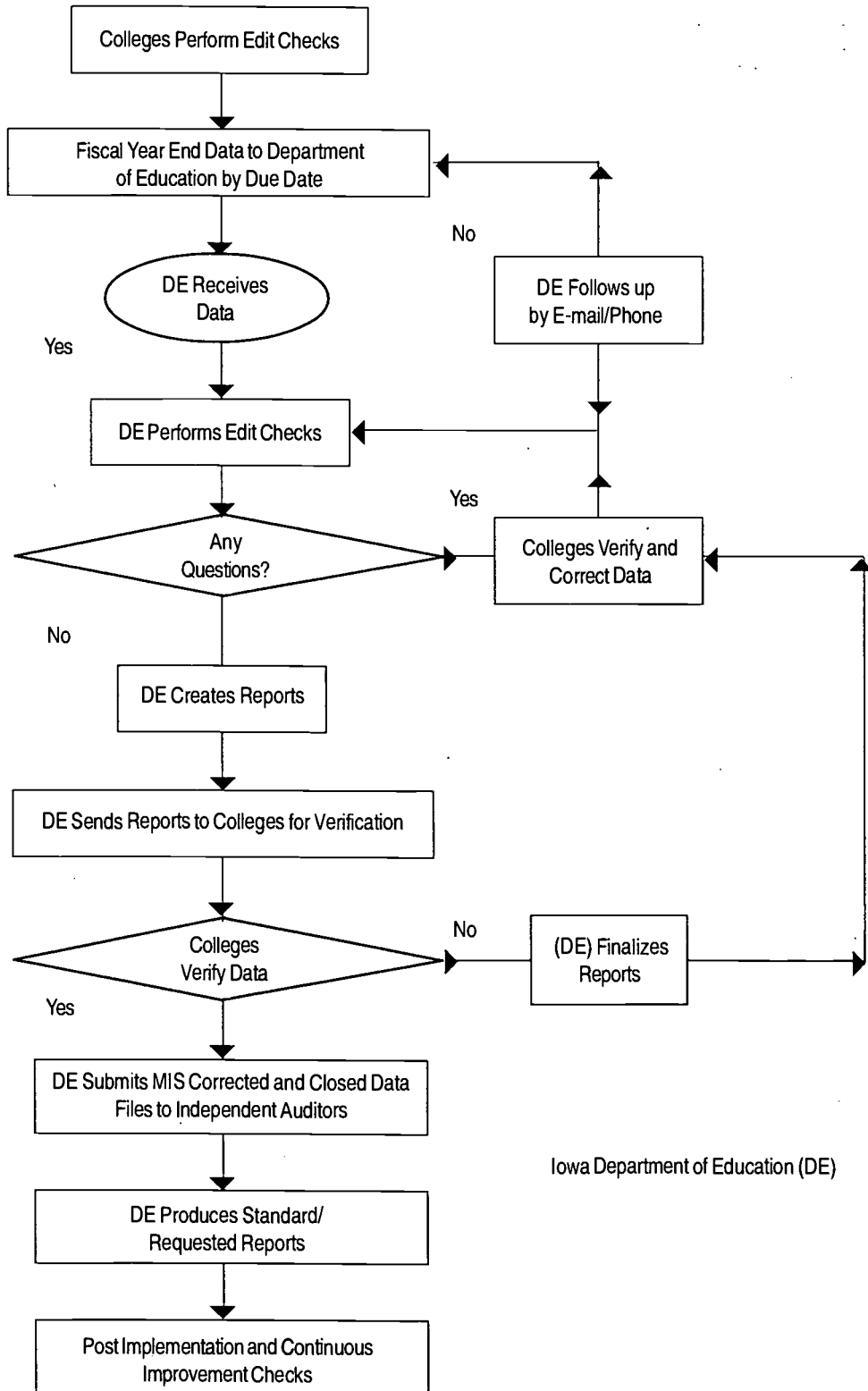
The MIS team visited each community college in February, March, and April of 2000 to present the process of data confirmation and participate in open discussions of individual college questions, problems, and concerns. Process improvement is an ongoing activity which involves both college and departmental staff and administrators.

The Community College Presidents and other community colleges liaison groups are updated on the status and progress of the MIS system. The topics of presentation have included the MIS data elements, submission dates for data and audits, and reinforcement of the accuracy of the data from the department.

Total Credit Enrollment and Total Credit Hours

As Table 1 indicates, the Fiscal Year 1998-1999 credit enrollment (unduplicated headcount) of Iowa's 15 community colleges totaled 93,140 ranging from a low of 1,355 to a high of 18,250. Credit hours totaled 1,383,233 ranging from a low of 23,715 to a high of 239,582.

Total credit enrollment and total credit hours are illustrated in Figures 1 and 2

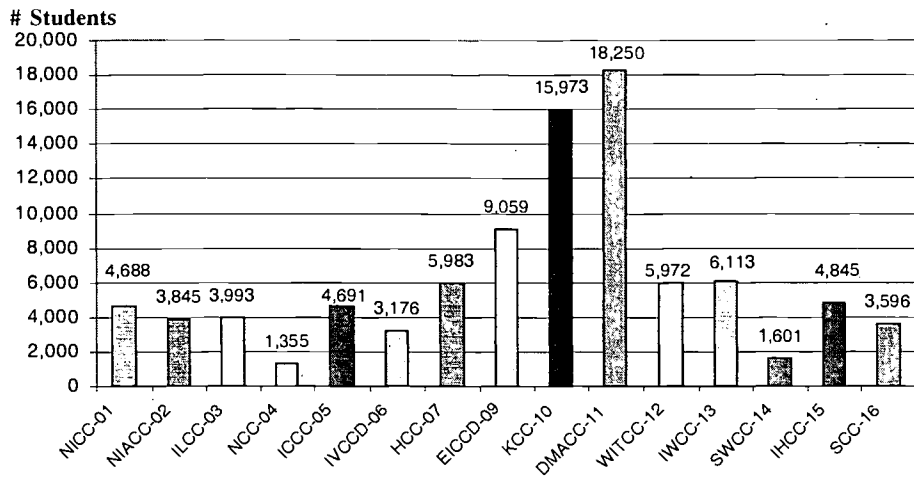

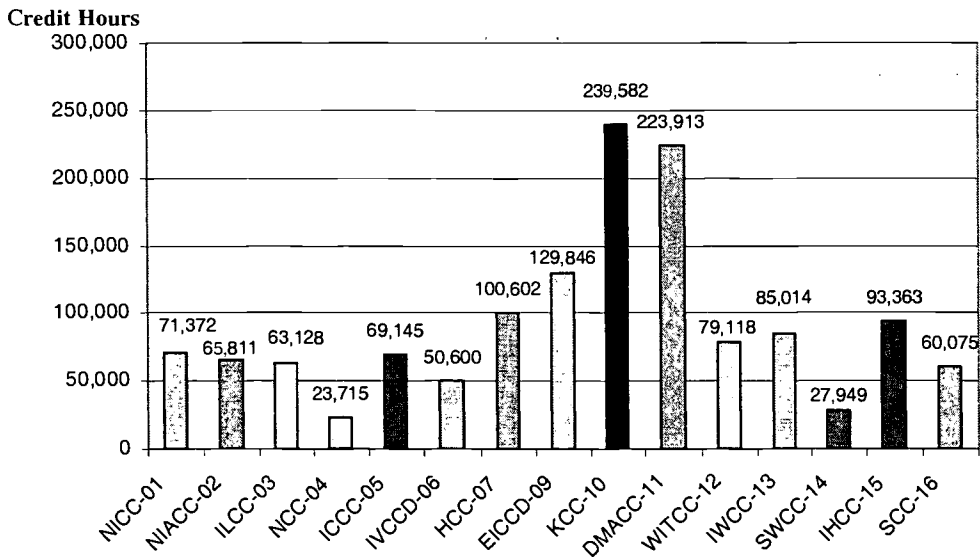
**Total Credit Student Enrollment by Iowa Community College

Full time calculations are based on 12 or more credit hours and utilize the fall term data only. (Indian Hills Community College is on the quarter system while the remaining 14 community colleges are on a semester term; Indian Hills Community College's full time status is eight credit hours/per quarter term.)

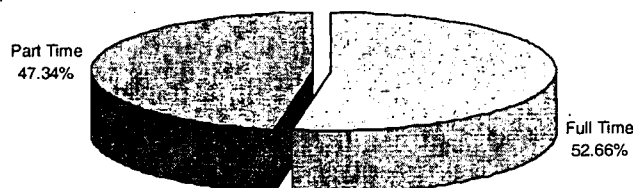

Full time and part time enrollment status is calculated utilizing fall Fiscal Year 1998-1999 enrollments. Statewide, approximately 53 percent of the fall 1999 credit students were full time, while approximately 47 percent were part time (see Figure 3). Full time status as a portion of total students ranged from a low of 43 percent, to a high of 72 percent (see Table 2).

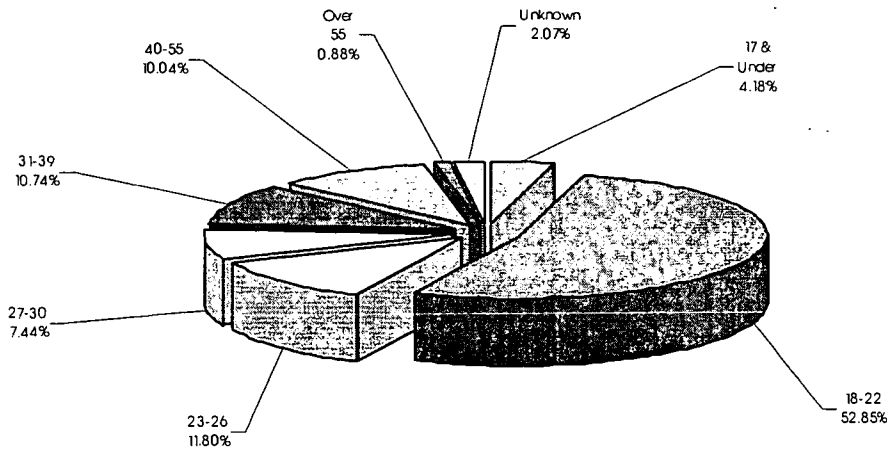

The average age of community college credit students is approximately 26 years of age; the median age is 21. Approximately 57 percent are 22 years of age or less. Less than one percent is over the age of 55 years. These data are provided in Tables 3 and 4; and illustrated in Figure 4.

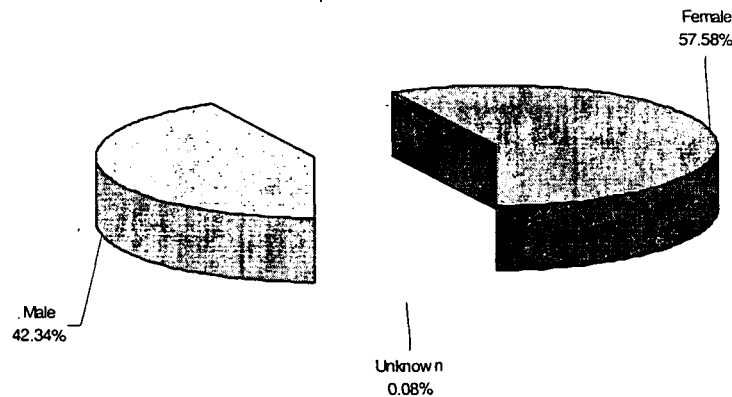

As Table 5 and Figure 5 illustrate, approximately 58 percent of the total Fiscal Year 1998-1999 credit students are female; 42 percent are male. The range of females as a portion of total college enrollment ranges was from a low of approximately 53 percent, to a high of approximately 62 percent.

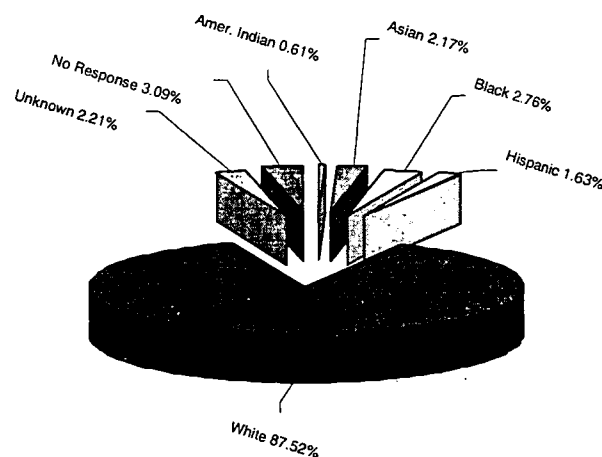

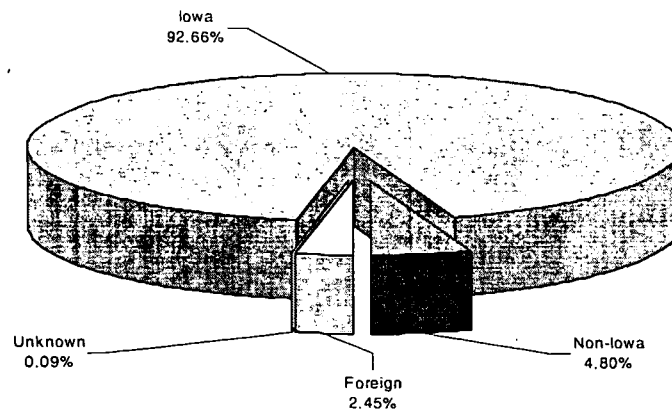

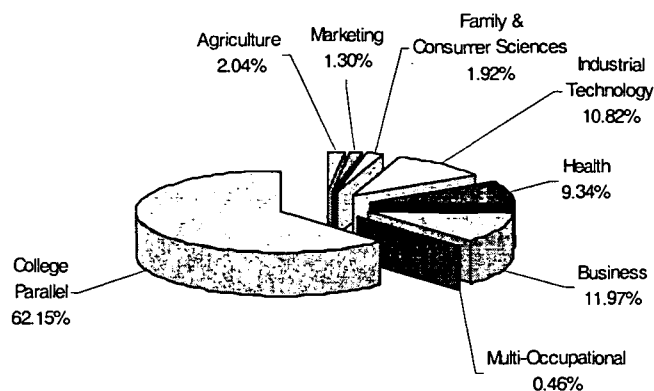

Fifty-nine thousand six hundred and fifteen (59,615), approximately 62 percent, of all credit students are majors in college parallel programs; business program majors total 11,486, the largest number of the vocational-technical program enrollees followed by 10,381 in industrial technology programs and 8,964 in health occupations majors. Marketing majors comprise approximately one percent of the total student population. These data are summarized in Table 8 and in Figure 8.

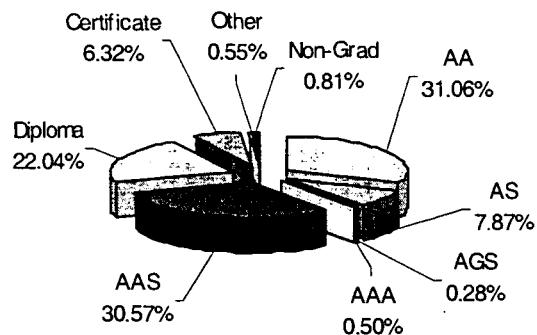

As Table 9 indicates, 11,874 credit awards were granted by the community colleges during Fiscal Year 1998-1999. Approximately 31 percent are associate of applied science and associate of applied arts degrees, while approximately 39 percent are associate of arts and associate of science degrees. Two thousand six hundred and ten (2,617), approximately 22 percent, diplomas, and 750 (approximately six percent) certificates were awarded.

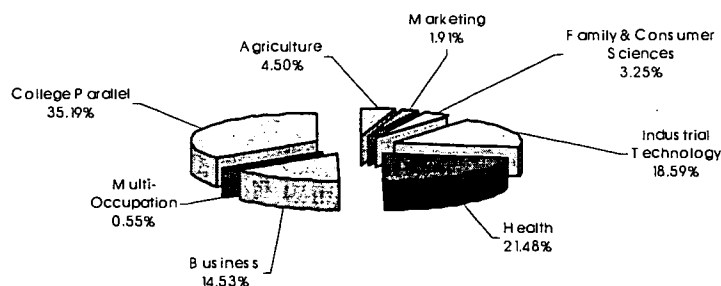

During Fiscal Year 1998-1999, 11,774 credits awards were granted by the community colleges. As provided in Table 10, and Figure 10, 4,143, approximately 36% of all awards were for completion of college parallel programs; the remaining awards were granted for completion of vocational technical programs. Approximately 21 percent of the graduates completed health occupations vocational-technical programs, while 19 percent completed industrial tech programs; approximately 15 percent received business program awards. These are data summarized in Figure 10.

In Fiscal Year 1998-1999, enrollments in non-credit classes totaled 616,825 (approximately 314,000 unduplicated headcount). Table 19 indicates a total of 11,109,226 contact hours. A total of 32,068 students attended adult basic education (ABE) and high school equivalency programs and courses, completing 4,720,484 contact hours. ABE/GED and ESL data are reported to the Department via a federal reporting process and were not identified as separate categories in the FY99 MIS data submission.

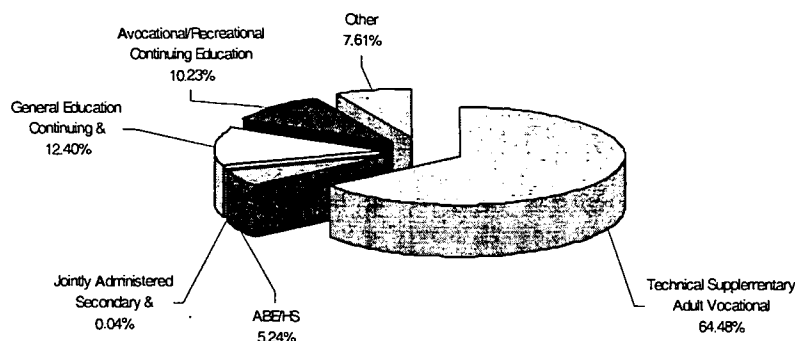

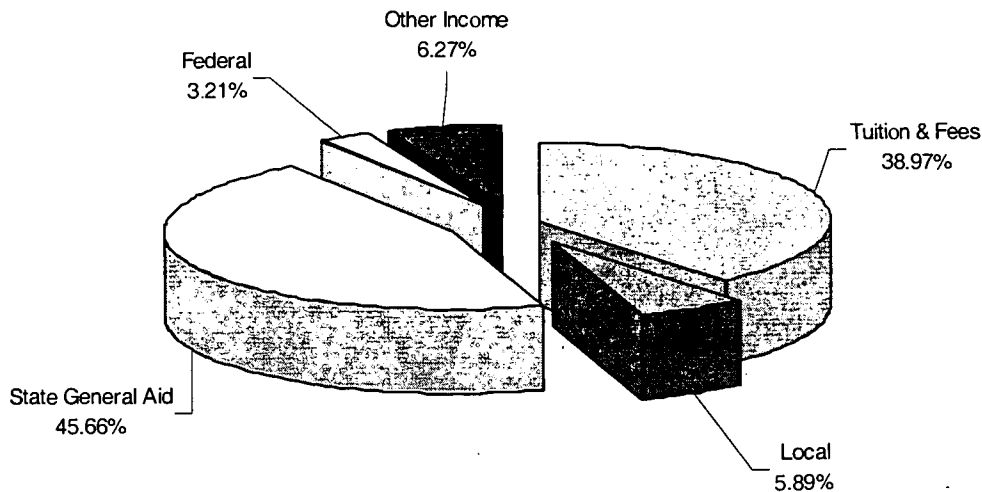

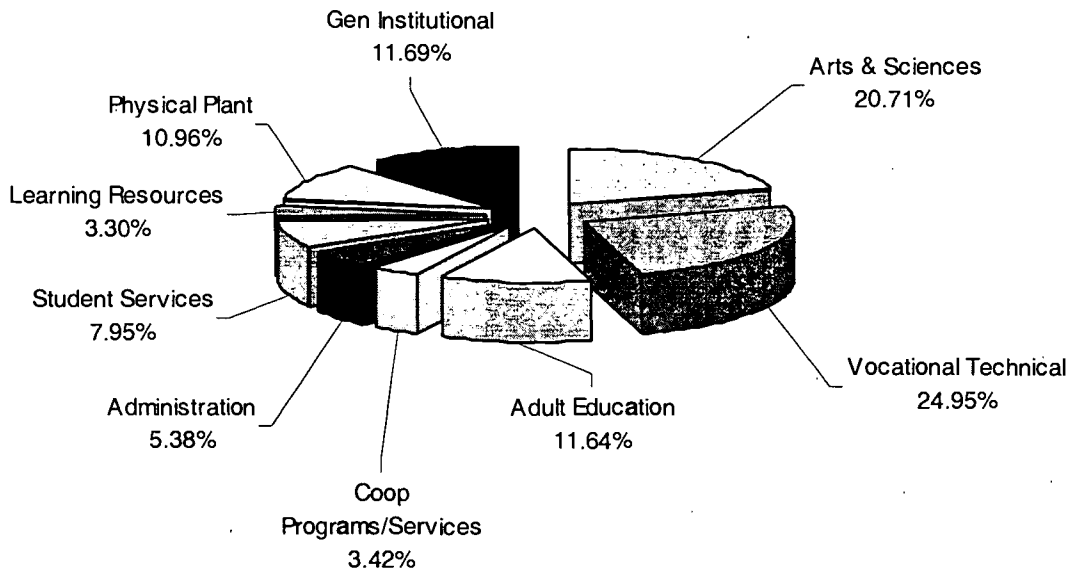

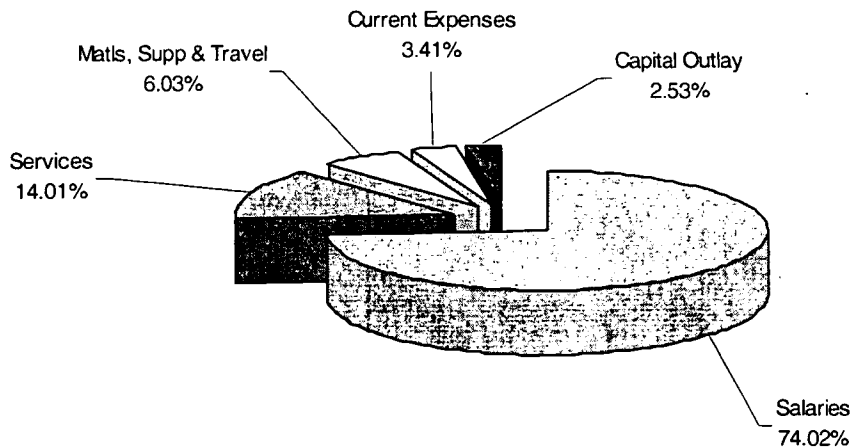

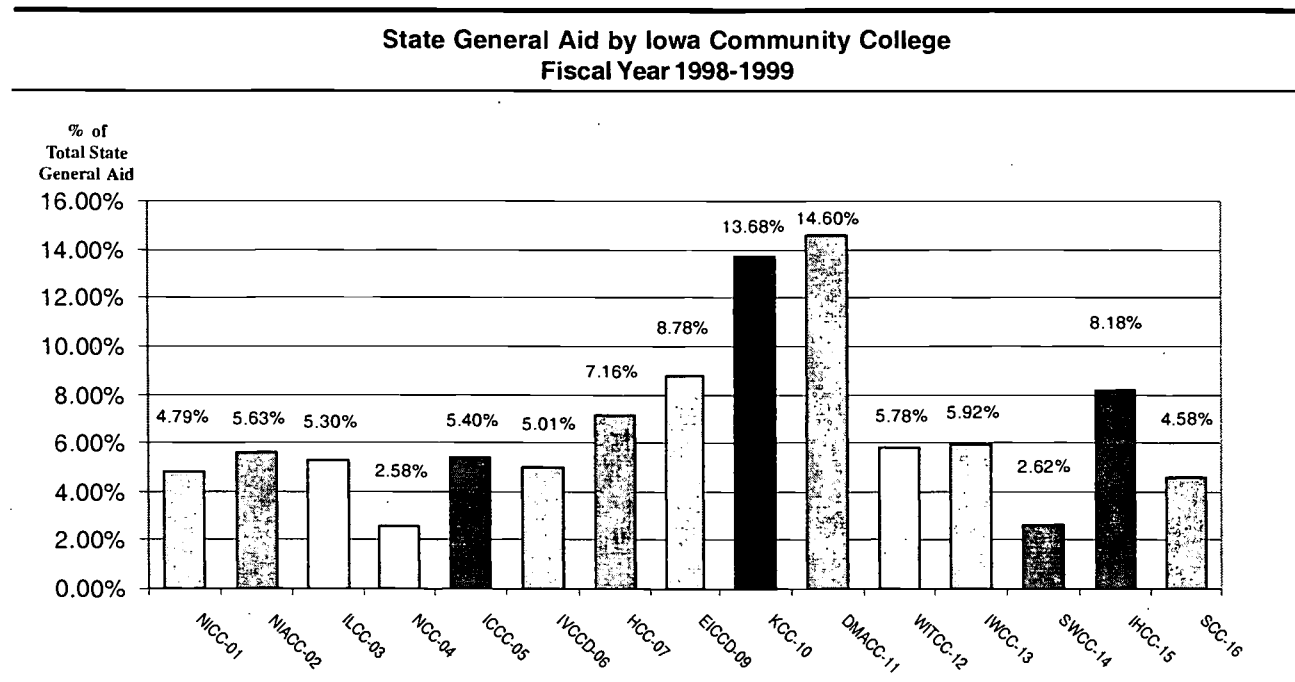

Table 25 and Figure 15 indicate the percentage of total state general aid distributed to each community college during Fiscal Year 1998-1999. The range varied from a low of 2.58 percent, to a high of 14.6 percent.

FTEE Calculation

Table 26 summarizes the Full-Time Equivalency Enrollment (FTEE) calculation utilized for the distribution of Fiscal Year 1999-2000 state general aid to community colleges. A total of approximately 76,150 FTEE were generated during Fiscal Year 1998-1999; credit enrollment comprised approximately 76 percent of the total FTEE, while non-credit contact hours constituted approximately 24 percent. The total credit hours of 1,383,233 generated approximately 57,635 credit FTEE, while the non-credit total contact hours of 11,109,226 generated approximately 18,515 FTEE. As Table 26 indicates, non-credit contact hours as a portion of an individual colleges' FTEE, range from a low of approximately 13 percent to a high of approximately 38 percent. Conversely, credit hours as a portion of total FTEE by individual community colleges ranged from a low of 62 percent, to a high of 87 percent. These data are illustrated in Figure 16.

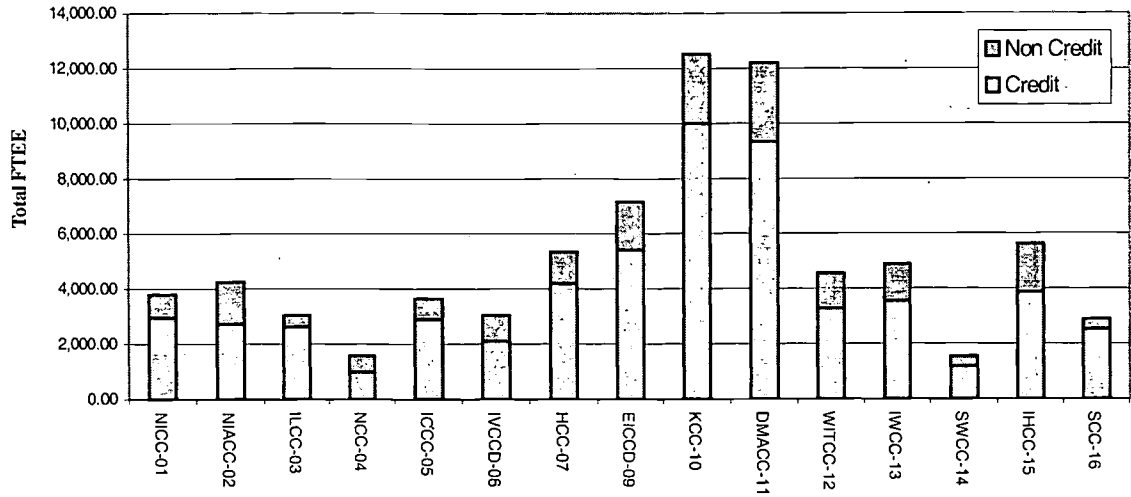

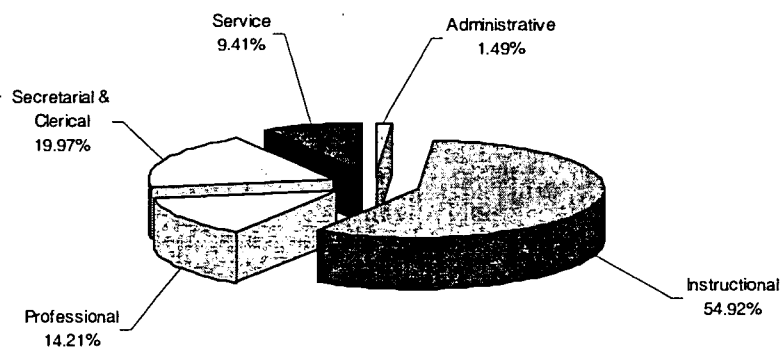

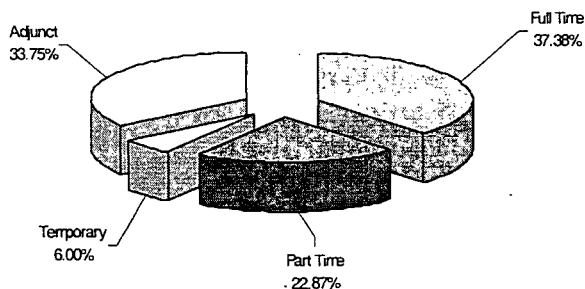

Iowa Community College Total Positions Fiscal Year 1998-1999



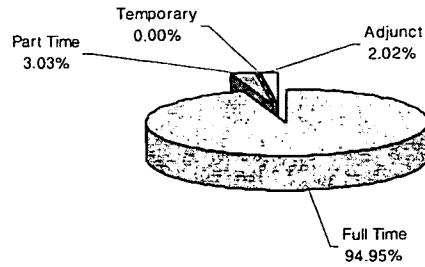

Fiscal Year 1998-1999**

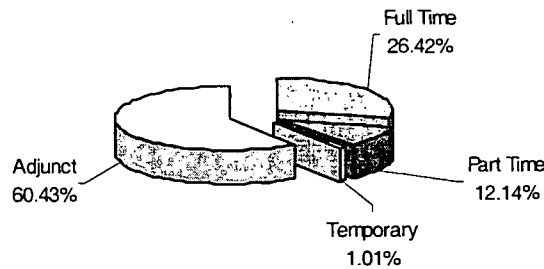

Fiscal Year 1998-1999**

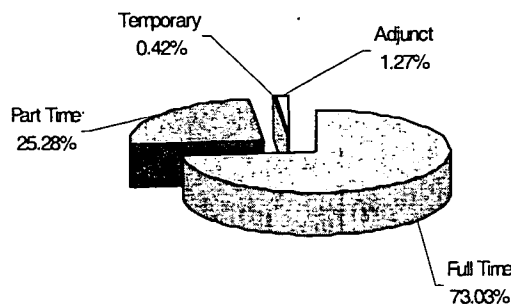

Fiscal Year 1998-1999**

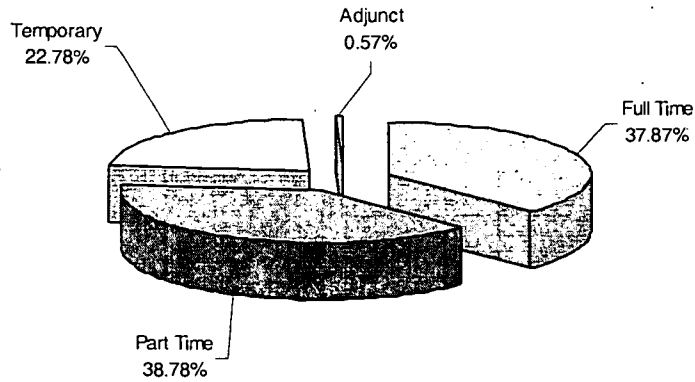

Fiscal Year 1998-1999**

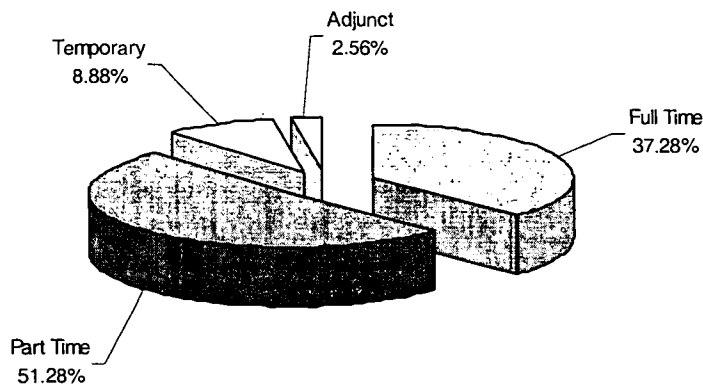

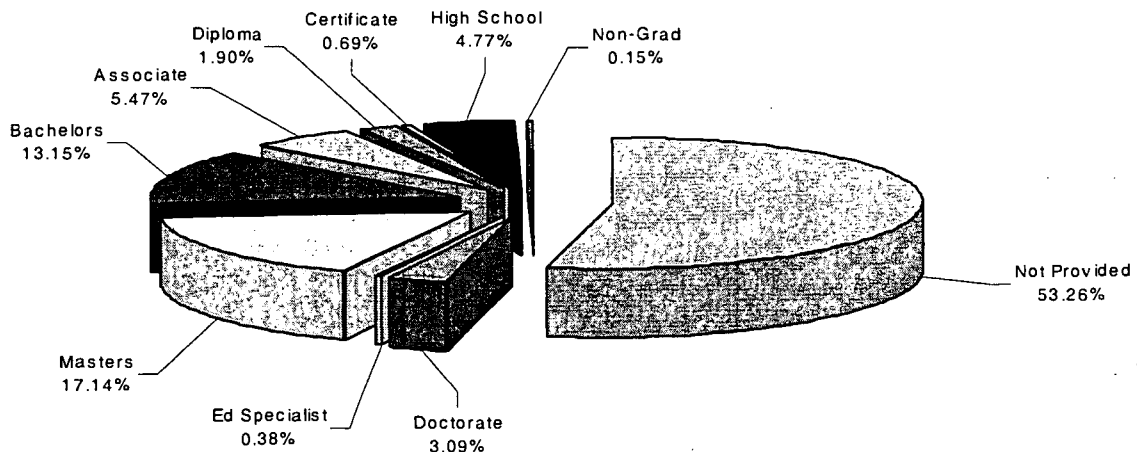

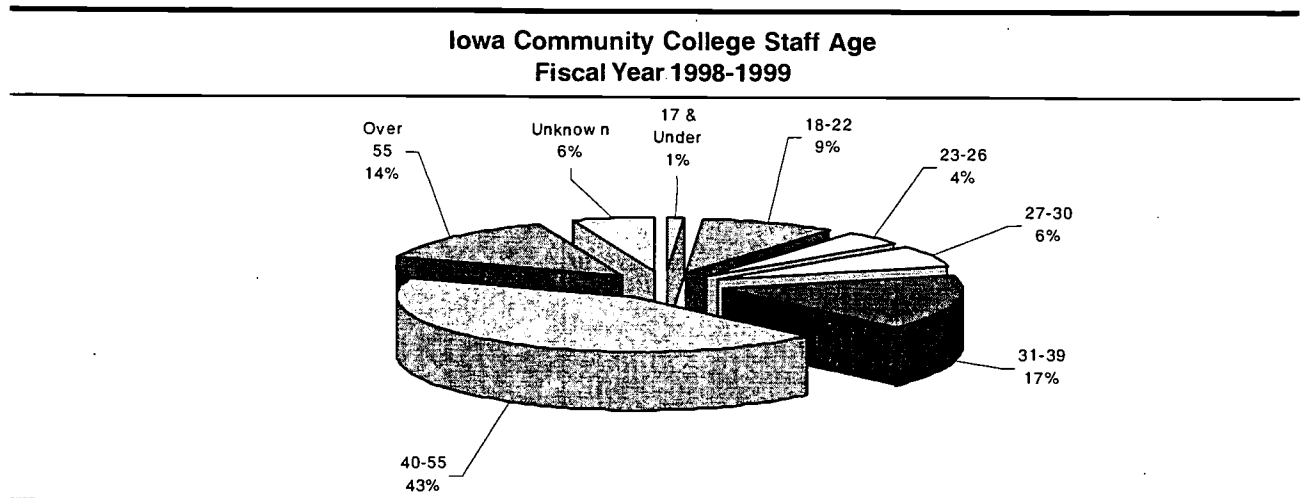

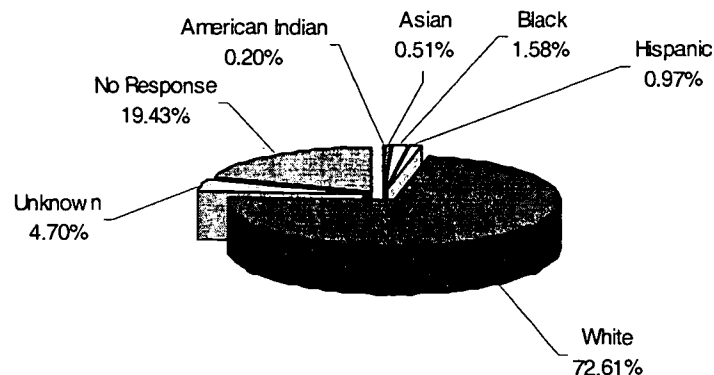

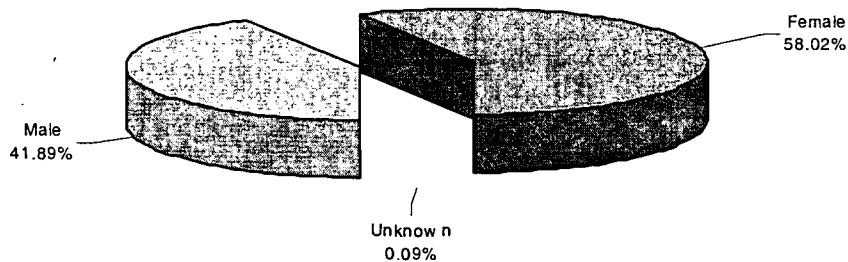

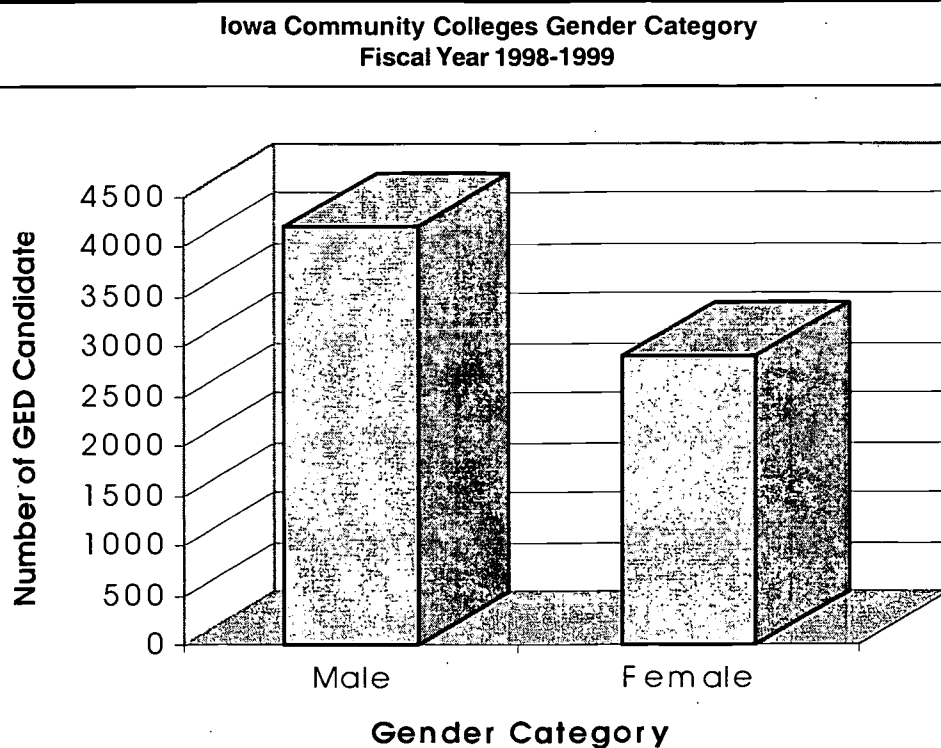

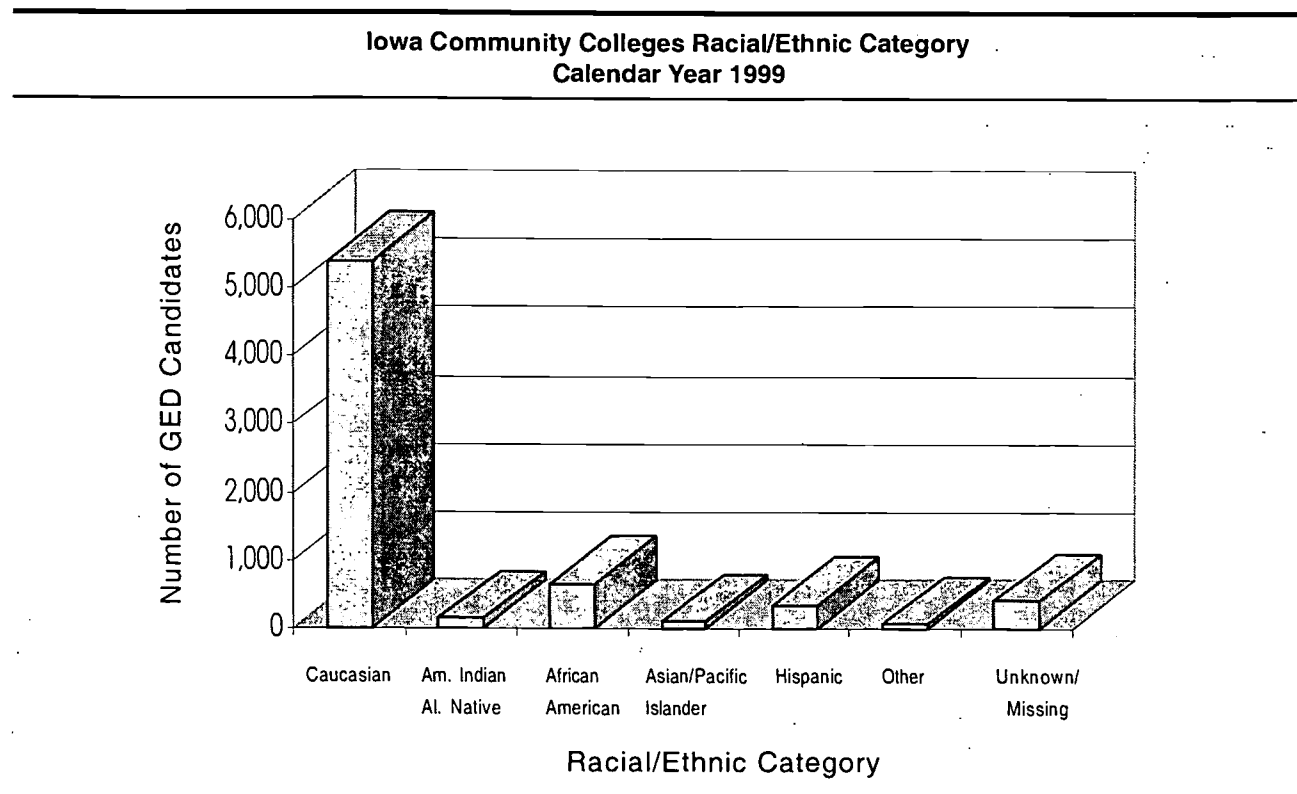

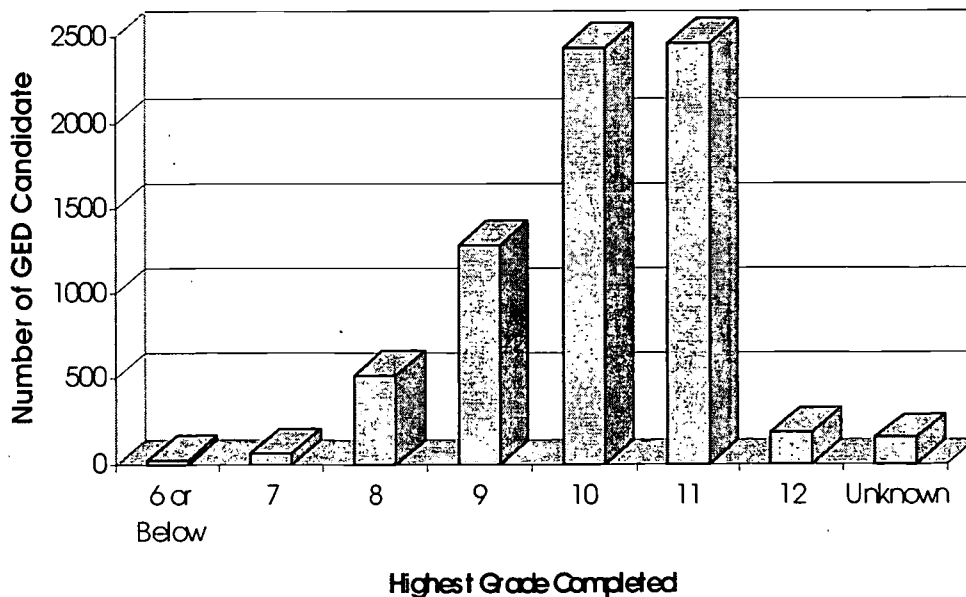

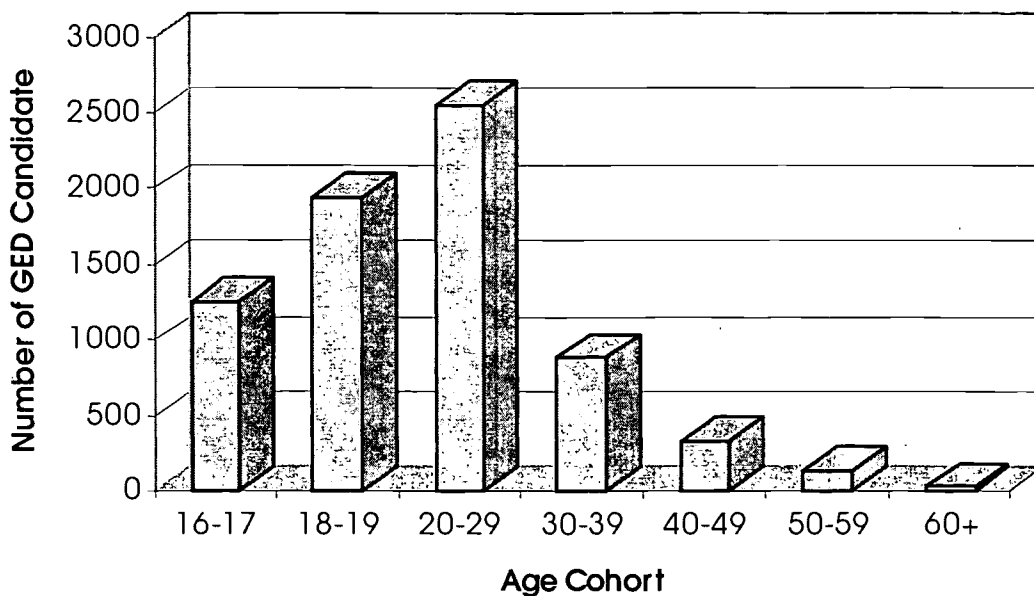


