ABSTRACT

This reference work is an updated guide to over 100 major national data sources related to higher education including surveys and databases, reports, statistical digests, and other means for making data available. It focuses on sources of data that are national in scope, updated and made available on a regular or periodic basis, and useful for policy analysis and development in relation to postsecondary education. Information on each source includes organization or agency name including acronyms, data source/title, description, data collected/reported, data availability, current data uses, publications, source/contact. The sources are grouped under five general topics and under each topic heading sources are listed alphabetically by organization. The five topics are (1) general references; (2) participation in postsecondary education; (3) finance and management; (4) faculty, staffing and salaries; and (5) physical facilities, libraries and assets. These sections are also marked with tabs. The compendium also includes an index and an appendix providing information on ordering materials from the National Center for Education Statistics (NCES). Or, just as likely to bring on a good headache, finding the right data involved multiple calls across the country tracing down vague leads. One of the oldest sources of key financial data is called *Grapevine*, with no irony intended. The *Compendium of National Data Sources on Higher Education* is simply the best remedy that I know for such headaches, and the best preventative of upper cranial congestion for all those, like me, who lack the mental storage necessary to recall how NLS-72 relates to HS&B, and how you can find IPEDS through CASPAR before you are EEO-6th. The *Compendium* will make you HEPI.

This is the third version of this sourcebook on national higher education data sources, each one a distinctive improvement and expansion of the last. The 1986 SHEEO publication called *Comparative Data About Higher Education* was replaced in 1991 by the first *Compendium of National Data Sources*, which updated and substantially expanded the earlier directory. This latest version again updates all of the sources included in the prior publications — necessary because of numerous changes in addresses and other particulars — and adds additional sources and types of data recently made available. Over one hundred sources are now included. In addition, this version reorganizes the entries to make them more readily accessible and provides a complete index for easy reference. Whether your information needs are specific and well defined or broad and in need of more concreteness, this *Compendium* will be an indispensable reference.

Alene Bycer Russell and Esther M. Rodriguez undertook the demanding work of updating and checking all of these sources and Adrienne Sack provided valuable production support. Much of this effort was done in addition to their normal workload. Their headaches will help to relieve yours.

INTRODUCTION

The need for data on higher education has never been greater. What does it cost to attend postsecondary education? How do tuition revenues compare to state, federal and private support? What are the characteristics of faculty members, and how much are they paid? How many students are currently enrolled in colleges and universities? How many adults are seeking additional education, what kind are they seeking, and where do they find it? What is the level of minority student participation and completion in postsecondary education, compared to majority students? How many students overall actually graduate, and how long does it take? How well do our elementary and secondary students achieve in certain key areas, and how does this compare to other countries? How prepared are high school graduates to face the challenges of college and the workplace? How do students finance their postsecondary education? What is the value of a college degree?

The questions are endless and the answers are not simple. Yet more and more, institutional and system administrators, state-level coordinating and governing boards, and other state and national policy makers are addressing these and many more critical questions. To do this, they must have good data. This means, most often, that they need good comparative data. They need to answer the question: how does my institution — or system, sector or state — compare to its peers? In addition to internal management needs, legislators and the public at large are increasingly asking difficult questions and demanding greater accountability. Again, reliable, timely and sufficiently detailed data are a must.

In response to growing data needs, the National Center for Education Statistics of the U.S. Department of Education as well as many state agencies and private organizations have stepped up their data collection and dissemination efforts. Numerous annual surveys are conducted, reports written, data tapes and diskettes produced and statistics compiled. The results are almost staggering. Statistics abound, describing virtually every facet of postsecondary education, broken down into numerous categories and sub-categories for every grouping one can imagine. Where does one begin?

This SHEEO *Compendium of National Data Sources on Higher Education* has an ambitious goal: to pull together and provide a guide to the major national data sources related to higher education in this country. This includes surveys and databases, reports, statistical digests and other means for making data available. The *Compendium* helps users find answers about current conditions, study over-time trends, and compare their own data with appropriate national peer data. This publication updates and expands our 1991 *Compendium*, reflecting changes that have occurred in higher education data since that time.

Sources Included in the *Compendium*

The SHEEO *Compendium of National Data Sources on Higher Education* focuses on sources of data that are national in scope, updated and made available on a regular or periodic basis, and useful for policy analysis and development in relation to postsecondary education. The *Compendium* includes more than one hundred sources that meet these criteria. However, because entries are limited to these broad criteria, good sources of data are left out. For example,

coordinating and governing boards typically have extensive data sets on institutions in their states and substantial analytical capability.

Many entries in the *Compendium* describe major national surveys or data collection efforts that include the entire universe of higher education institutions. Often, these focus on particular subject areas such as fall enrollment or institutional revenues and expenditures. The Integrated Postsecondary Education Data System (IPEDS) of the National Center for Education Statistics, U.S. Department of Education, is the most comprehensive data collection effort of this type in the country, with a series of surveys on specific topics conducted either annually or biennially. Other entries focus on sample-based studies which collect information from institutions representative of the nation as a whole. Still other sources may characterize one particular sector of the postsecondary community such as community colleges or independent colleges and universities. These may consist of full universe surveys or have a sample design, but in either case, provide reliable data on that particular sector only.

Other sources rely on student-based data, particularly data-based on sample surveys of the student population. For example, the National Postsecondary Student Aid Survey (NPSAS) provides data on the socioeconomic characteristics of postsecondary students and their parents, and the National Assessment of Educational Progress (NAEP) includes data on the basic skills proficiencies of students at different grade levels.

The *Compendium* also contains sources and surveys in which the state is the unit of analysis, rather than the institution, institutional type or student. For example, there are sources that describe state appropriations to higher education and state governance structures. Other sources compile institutional-level data to present state-level statistics for inter-state comparisons.

Some sources in the *Compendium* bring together data from many different sources instead of collecting additional primary data. Often a good starting place for research, these key sourcebooks contain data on many topics for many kinds of institutions. Other sources describe data exchanges among groups of similar institutions, and still others offer opportunities to request specialized analyses.

Finally, several sources provide data related to higher education policy issues, for example, sources relating to elementary/secondary education and demographic trends. These are included since they are often of use to postsecondary researchers and policy makers, even though they do not contain higher education data *per se*.

In sum, though the sources in this volume were selected because of their common features — being national in scope, updated regularly and useful for policy analysis — their differences are considerable. Readers should take the time to study the descriptive material presented in this volume before requesting or purchasing materials.

Types of Information Included on Each Source

Each entry in the *Compendium* contains the following information:

- Organization/agency name, including any acronyms.

- Data source/title, either the title of a specific report (in italics) or the title of a survey project, depending on how the source is most commonly known.
- Description, including type of source (annual report, survey, sourcebook and so on), who is included in the sample, sample size, when the source was begun, data collection cycles, types of data breakdowns, agency information and other relevant material.
- Data collected/reported, listing representative data elements collected or reported in the data source.
- Data availability of printed reports, various computer formats (tape, diskette, CD-ROM disc), and opportunity for custom analyses. Cost is listed whenever the information was provided.
- Current data uses. A short description of how the data are used and by whom.
- Publications. In cases where many reports are based on a data source, all major report titles are listed here in chronological order, with publication date or "annual" indicated in parentheses. Occasionally, further descriptive information is given for particular reports. If only one report is produced regularly, this section was omitted, since that report title is treated as the "data source/title." In a few cases, "Related Publications" are included, typically major one-time-only reports, related to the topic, but not based on the particular source being described.
- Source/contact, including organization/agency address and phone number for ordering information, as well as the name of a contact person if the user is interested in substantive information about the source. If there are different phone numbers for more information and for ordering reports, both are listed. Please note that for NCES reports only, readers are referred to the Appendix for ordering information.

How to Use the Compendium

Users should note that there are two principal ways to search for materials in the *Compendium*, and the best approach depends on the user's particular questions and level of familiarity with the data sources. Generally speaking, the Table of Contents will be more useful for those wanting a general overview of data sources pertaining to broad topical areas, and the Index will be more useful for those with a particular organization or title in mind, or having a more narrowly-defined research interest.

Table of Contents. The Table of Contents contains a complete listing of individual data sources and page numbers, grouped under five general topics. This provides a brief overview of what is available in each subject area. Under each topic heading, sources are listed alphabetically by organization, matching the order in which these sources appear in the *Compendium*.

The five topics consist of:

- General references. These include statistical digests or sourcebooks, directories, data exchanges, census information and other reference materials. Often it is useful to turn to sourcebooks first for summary data before consulting the more specialized data sources listed elsewhere.
- Participation in postsecondary education. This section includes data on enrollment and completions; assessment and testing; adult, workforce and vocational education; longitudinal surveys describing progress in school or college through participation in the workforce; and other student data.
- Finance and management. This includes data on government finances such as state appropriations to higher education; institutional finances; tuition and fees; student financial aid; cost of living; and other economic and financial data sets.
- Faculty, staffing and salaries. Data on the number of faculty and tenure status of faculty, faculty and staff salaries, faculty workload and attitudes, and related data are included here.
- Physical facilities, libraries and assets. This section contains data sources describing physical facilities, library operations, and other capital or related assets of higher education.

Index. A comprehensive index is found at the back of this *Compendium* to help users identify data sources more quickly. The index contains page references for all of the following:

- Organization/agency name. This is useful if the reader knows that a particular organization has published a report on a subject, but does not know the title, or if a reader wants to know the kinds of publications produced by a particular organization.
- Data source/title. This provides a quick way to find a data source if the exact title is known.
- Topic. Approximately 40 topics are included in the index, and specific data sources may be cross-referenced in several places. Thus, when a narrow topic is being investigated, using the index can speed up the search. For example, although all sources on "enrollment" are found in section II, and all sources on "tuition and fees" are found in section III, the index points quickly to the exact pages on which these sources will be found. Also, the index includes topics that cross-cut the five broad topical areas. For example, one can look up "minorities" or "opinion surveys" in the index and find references in more than one section.

Please note that comprehensive statistical digests are identified as "sourcebooks" in the Index, and are also cross-referenced under each of the major topics they address. Since these reports are so comprehensive, however, we did not list them in the Index if only minimal data on a topic

were included. Therefore, we encourage users to explore these sourcebooks carefully before moving on to more specific data sources.

The *Compendium of National Data Sources on Higher Education* does not advocate or promote the use of any particular data sources. Rather, we hope to encourage researchers and policy makers to take advantage of the variety of national data sources available. Although this publication aims to be as comprehensive as possible, both in terms of sources selected for inclusion and descriptive information provided, the reader must make the final decisions about what data sources to use.

Ordering Materials from NCES

The Appendix to this *Compendium* includes a guide to ordering materials from the National Center for Education Statistics (NCES), the largest producer of higher education data in this country. We recommend that *Compendium* users review this information to become familiar with the expanding options and formats through which data are now being disseminated by NCES. That is, in addition to printed reports, one now has access to data tapes, diskettes, CD-ROM discs and other specialized services. Of particular note is the new IPEDS analytical data file on CD-ROM disc which will be available after September 1993.

DATA SOURCE/TITLE: *Campus Trends*

DESCRIPTION: This report, published annually since 1984, describes changes taking place in the academic and administrative practices of American colleges and universities. Based on a survey conducted annually through the Higher Education Panel, a survey research program of ACE, it includes responses from over 400 senior administrators, and describes higher education as a whole as well as changes affecting two-year public institutions, four-year public institutions, and four-year private institutions. A brief narrative report is followed by detailed tables.

- Changes in operating budgets
- Impact of financial pressures
- Changes in enrollment
- Actions to improve minority participation
- Changes in student retention
- Patterns of faculty hiring

The CASPAR system runs on IBM PC-AT, PS/2, or compatible systems with a 80286, 80386, or 80486 microprocessor, 640K bytes of RAM, 1M bytes of XMS or EMS RAM, and a 40-megabyte hard disk. A larger hard disk and fast 80386 or better microprocessor are recommended, particularly for the larger data sets (the complete system is approximately 210 megabytes and growing). A CD-ROM drive with the Microsoft CD-ROM Extensions dated 4/89 or later, and a DOS version 3.3 or later operating system are required to access the CD-ROM. CASPAR will function properly as a DOS application under Microsoft Windows version 3.1 or later.

DESCRIPTION: High School and Beyond (HS&B) is the second longitudinal study conducted by the National Center for Education Statistics. It begins with high school students and follows them after graduation to postsecondary education and work. The base year sample survey was conducted in 1980 and collected data from over 58,000 students (30,000 seniors and 28,000 sophomores) from over 1,000 public and private high schools from across the country. Base-year and follow-up surveys collected data on students, their parents, the schools attended, and observations from teachers.

DATA COLLECTED/REPORTED: The student questionnaire examines such areas as school experiences, test scores, school performance, and future educational plan and occupational goals. The school questionnaire provides information on enrollment, staff, educational programs, dropout rates and special programs for the handicapped and disadvantaged students. The teacher checklist provides teacher observations of students in and out of the classroom. The follow-up questions reflect areas such as work experience, postsecondary education experience and job satisfaction.

Follow-up surveys of subsets of both sample cohorts (sophomores and seniors) were conducted at two-year intervals in 1982, 1984 and 1986. Another follow-up of the sophomore cohort was conducted in 1992, with all postsecondary transcripts collected in 1993.

DATA AVAILABILITY: Published reports are available through the U.S. Government Printing Office. The Student Survey data tapes are available for \$175 (BPI 6250) and \$225 (BPI 1600). Specialized Analyses

The National Data Resource Center (NDRC) was recently established by NCES to provide access to much of the data that NCES maintains. Users may request specific statistical analysis on a data set and NCES will provide tables and reports, or users may come to the NDRC offices and perform their own analyses. There is no charge for this service, and the normal turnaround time is four to six working days. NDRC uses the SAS programming language to perform the actual analysis. By request, NDRC also will provide institutional listings and mailing labels.

Currently the available databases include: all IPEDS surveys, Schools and Staffing Survey, Private School Survey, National Survey of Postsecondary Faculty, Common Core of Data, High School and Beyond, National Postsecondary Student Aid Study, National Longitudinal Study, National Education Longitudinal Study and Recent College Graduates Study. In the future, NCES plans to add additional databases to its inventory and to link the database files so that researchers can perform higher level analyses.
