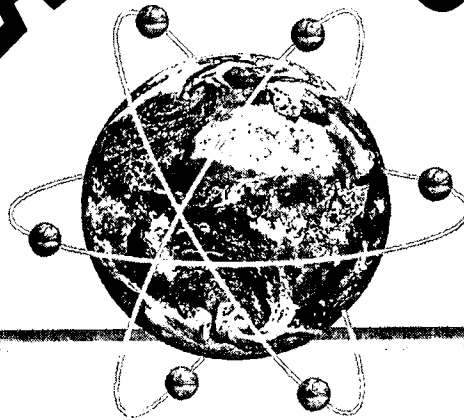

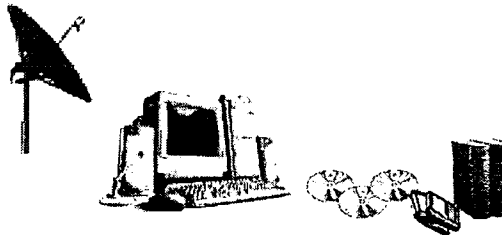

**Husbands' involvement in abortion in Vietnam.** *Studies in Family Planning* 29(4): 400-413, December 1998.

This study analyzes involvement of men in abortion in Viet Nam, where induced abortion is legal and abortion rates are among the highest in the world. Twenty men were interviewed in 1996 about the role they played in their wives' abortions and about their feelings and ethical views concerning the procedure. The results showed that both husbands and wives considered the husband to be the main decisionmaker regarding family size, which included the decision to have an abortion, but that, in fact, some women had undergone an abortion without consulting their husbands in advance. Parents and in-laws were usually not consulted; the couples thought they might object to the decision on moral grounds. Respondents' ethical perspectives on abortion are discussed. When faced with an unwanted pregnancy, the husbands adopted an ethics of care and responsibility toward family and children, although some felt that abortion was immoral. The study highlights the importance of understanding husbands' perspectives on their responsibility and rights in reproductive decisionmaking and their ethical and other concerns related to abortion.

**Population policy, son preference and the use of IUDs in North Vietnam.** *Reproductive Health Matters* 16(11): 66-76, May 1998.

This paper discusses contraceptive use and discontinuation among women in north Viet Nam, in the context of a strong cultural preference for sons and a stringent two-child population policy. Among a random sample of 1432 married women aged 15-49 in north Viet Nam in 1994, nearly 60 per cent used the intrauterine device (IUD) for contraception; other modern methods were hardly used at all. Overall discontinuation rates were high - nearly 45 per cent after three years; the most common reason was expulsion. Women without sons reported significantly higher rates of IUD discontinuation due to expulsion or contraceptive failure than women who had a

son. This is an indication that women without sons had deliberately removed the IUD and reported this as an expulsion or contraceptive failure, in hopes of satisfying their families' wish for a son, while avoiding the criticism of deliberately exceeding the two-child limit. Assessment of medical technology usually consider only clinical and service aspects. A gender analysis of contraceptive effectiveness data that also takes into account the social, cultural and political context, can offer insights into the complexities of women's reproductive lives and the contradictory demands on their fertility.

**Induced abortion in Latin America: strategies for future social research.** Reproductive Health Matters 6(11): 55-65, May 1998.

This paper analyzes the present state of knowledge on induced abortion in Latin America based on a critical review of information from regional meetings and seminars in the 1990s and articles in international journals in the field. It focuses on the incidence of abortion, the abortion decision-making process, and the political and public dimensions of induced abortion, and discusses theoretical and methodological aspects of abortion research, and ethical and political concerns. It calls for the consolidation of the data obtained to date; the introduction of new theoretical frameworks and approaches from other disciplines; the reduction of inequalities in the available knowledge between countries in the region through national and comparative research; and deeper analysis of the political dimensions of induced abortion, particularly matters of legislation, public debate and health programme development.

**Preventing unsafe abortion in Western Kenya: an innovative approach through private physicians.** *Reproductive Health Matters* 16(11): 77-83, May 1998.

This paper describes the first year's experiences of a project launched in Western Kenya to form a network of private physicians and train them to provide comprehensive, affordable post-abortion care and family planning. Links between this network and primary health care workers and local women's groups are currently being made and will further enhance the potential for reducing the incidence of both unwanted pregnancies and dangerous abortions. Setting up and expanding such networks is an important practical and innovative approach to realising the goals of safe motherhood.

**The contraceptive potential of lactation for Bangladeshi women.** *Asia-Pacific Population Journal* 13(4): 3-32, December 1998.

Longitudinal data from two surveillance sites, one urban and one rural are used to explore the contraceptive potential of lactational amenorrhoea in Bangladesh. Full breastfeeding is shown to afford significantly greater contraceptive protection than partial breastfeeding, though partial breastfeeders are also found to enjoy good protection against pregnancy while amenorrhoeic. The results also suggest that lactational amenorrhoea can afford good protection against pregnancy beyond six months postpartum. Also, older women seem to have significantly lower risks of conception during postpartum amenorrhoea than younger women. This article suggests that active steps should be taken to incorporate lactational amenorrhoea into postpartum family planning strategies in Bangladesh and identifies a number of barriers, both client and service-related, that currently inhibit this development.
