## The Paul J. Meyer Family Endows the Del Chesser Scholarship in Accounting

n recognition of Del Chesser's outstanding teaching as an accounting professor and for his work as a researcher and author in the field of accounting, Paul and Jane Meyer of Waco have established a \$100,000 scholarship in his honor through the Passport to Success Fund of the Waco Foundation.

The Dr. Delton L. Chesser Accounting Scholarship will be awarded to economically disadvantaged students who have already completed two years of technical or junior college study and wish to complete an education in accounting at Baylor. The first recipient of this scholarship should be named this fall.


"Encouraging students to attend college and providing financial assistance is a civic responsibility," says Paul Meyer, "but encouraging and rewarding excellence in teaching is also a community's responsibility."

Business leader, author and philanthropist Paul J. Meyer established the Passport to Success Foundation in Waco in 1988 to help 1) eliminate poverty by providing a better educated workforce capable of making a productive contribution to the economy, 2) make it possible for more people in the community to reach their full potential, and 3) make Waco a better place in which to live. This nonprofit organization was built upon the belief that "any significant progress in solving the basic problems of society must originate in the private sector."

To date, a total of more than 600 students have begun college work thanks to support from Meyer's Passport to Success (PTS) scholarships. Ten of them have graduated from Baylor University. Russell Duckworth BBA '89 was Baylor's first PTS college graduate; Eva Martinez BA '93/MS '95 was the first PTS recipient to earn a master's degree here; and Tom Stanfield BBA '94/JD '96 was the first to earn a Baylor law degree with help from PTS.

In 1996, Passport to Success joined forces with the Waco Foundation to provide a comprehensive collaborative approach to the higher education needs of McLennan County high school graduates. The foundation's MAC grant

program provides two-year scholarships for study at a McLennan County technical or junior college, while the PTS Fund provides scholarships for advanced study at a four-year college.

"The accounting department is extremely pleased that the Meyers have designated this new scholarship for accounting students at Baylor," says Dan Hollingsworth, chair of the accounting department. "And we're equally happy that it carries the name of Del Chesser, whom we consider very worthy of this honor."

Says Chesser, "Speaking as a member of our department's integrated core curriculum faculty, I hope the Passport to Success scholarship will enable many deserving students to experience the latest in accounting education that is being offered here at Baylor.

"Our 24 semester-hour integrated core curriculum, which is one of only four such programs nationwide, not only integrates topical material cross such areas as taxation,

information systems, auditing and financial accounting but also focuses on enhancing nontechnical competencies such as writing, listening, critical thinking, group dynamics, and conflict resolution.'

## Delton L. Chesser

Del Chesser holds the Roderick L. Holmes Chair of Accountancy and was named the 1996 Distinguished Professor of the Hankamer School of Business.

During his 14-year tenure at Baylor, Chesser has consistently received high teaching ratings from his students and has published numerous articles in major accounting journals. He has served as director of Baylor's Master of Taxation Program as well as director of the accounting department's internship program.

Chesser holds a BBA from the University of Texas, an MBA from the University of North Texas, and a PhD from the University of Arkansas-Fayetteville. Before joining the Baylor faculty, he taught for nine years at the University of Nebraska-Lincoln
