Relations between Iraq and the EU are based on agreements covering cooperation and assistance. Iraq is an important partner of the European Union and Iraq's relationship with the EU strengthens "two bilateral agreements: a memorandum of understanding on energy cooperation signed in 2010 and a partnership and cooperation agreement signed in 2012. The first is a framework for energy cooperation, while the Convention Second, a wide range of issues, including counter-terrorism and trade ".6

The war and internal conflicts have led to many disturbances in Iraq in recent years. The European Union has provided assistance through the provision of humanitarian assistance, the development of political and electoral processes, the promotion of human rights and the rule of law, the development of civil society organizations and the provision of basic services such as water, health and education.

The role of the European Union mission in Iraq, a diplomatic mission working closely with the embassies of 13 member states in Baghdad, and there is also a mission in the Kurdistan region in the province of Erbil.

The Mission ensures the completion of the tasks in both Baghdad and Erbil and is the permanent and main interlocutor of the European Union with the local authorities, the international community and the stakeholders for all matters related to the EU's external activities and cooperates extensively with all diplomatic missions. The mission seeks to ensure unity, coordination and effectiveness of the European external service in Iraq. It also emphasizes the guarantee of mutual relations in politics, economy, trade and the mission's interaction with the broad political and economic agenda between the EU and Iraq, The Mission ensures the completion of the tasks in both Baghdad and Erbil and is the permanent and main interlocutor of the European Union with the local authorities, the international community and the stakeholders

for all matters related to the EU's external activities and cooperates extensively with all diplomatic missions. The mission seeks to ensure unity, coordination and effectiveness of the European external service in Iraq. Political analysis and reports are important missions of the mission, which are widely viewed beyond classic policy, security policy, and comprehensive analysis and tasks to ensure coherence and coordination in all aspects of the EU's external service. In order to achieve these priorities, the Mission has been providing official endeavors and positions and carrying out awareness-raising activities, including external perceptions of the EU's internal policy, and in order to pursue this process, UNMIL has established eight local working groups in Baghdad and Erbil that are consistent with the views of Member States, Common European Union Messages ".8

Fourth : Iraq and the Other (United States of America)...

It is important to discuss the issue of American political behavior. He said that he started from a direction towards the Middle East, including Iraq, which is characterized by a change in the regimes that the United States has described as autocratic and democratic. The observer can not establish any bilateral relationship between two countries without going into details of the parties, internal and

external. The two countries - affecting this relationship, "On the Iraqi side, we see the phenomenon of the proliferation of gender and partisan and sectarian, national, ethnic, sectarian and religious in their direct dealings with the American parties; and this phenomenon in the science of politics is unhealthy phenomenon it can not last,

This is the "identification in the lack of clarity of the roles of the Iraqi parties gave an excuse and scope for the various American parties in dealing directly and influential on the Iraqi scene; here we see the direct impact of the decisions of the US Congress on the Iraqi reality, as well as the role of US ministries, and government institutions, And the American interlocking in the relationship made the process of American influence on the Iraqi decision process is not difficult and can be changed according to the interests of the parties and not according to the higher interests of both municipalities, on the other hand made the process of the impact of the Iraqi government on The American decision is more difficult; the need of the central government to influence the Iraqi and US parties together ".

THE SECOND TOPIC ANALYSIS OF TABLES FOR THE SAMPLE OF THE RESEARCH...

The main categories were identified according to a comparative analysis of what the newspaper Al-Sabah published during the period of the research on subjects related to the European Union and

the United States of America. Therefore, the different categories came according to the topics monitored in Al-Sabah newspaper.

The total number of topics in the newspaper Al-Sabah about the position of the European Union on the Iraqi issue during the period of the research (76) topic, either the number of topics on the position of the United States of America on the Iraqi issue has reached (102) topic. The results of the search for Al-Sabah newspaper as follows ...

It is clear from Table (1) that the economic topics ranked first in terms of the number of repetitions, which amounted to (22) topics in the morning newspaper, which was within the attention of the European Union .. In second place and in the preparation of a repetitive time came the subject of pressure on the World Bank topics (19) It is clear that the economic situation was the most important for the European Union because of its association with the interests of the European Union countries with Iraq economically, despite the many problems that Iraq suffers from the economic side, while the other subjects (security - against terrorism - military) In the following ranks and in the preparation of a different frequency from the previous and close to each other despite the political situation of concern in Iraq, but with the end of large armed battles with terrorist organizations, the priority of the European Union took a different from the previous period.

Results

Through the analysis of the sample, we have clarified the idea that the newspaper Al-Sabah has clearly emerged from the public policy of the State in relation to external relations with the parties with which Iraq has interests (seem common) regardless of the reality of these relations and their negative effects on Iraqi society now and in the future ..

1 - occupied the economic affairs in Iraq ranked first in terms of interest of the European Union according to the newspaper published the morning of topics during the period of research, which indicates that Iraq is the appropriate investment area for the European Union.

2 - The newspaper to provide the nature of the position of the European Union from Iraq the position of supporting and supporting him, especially with regard to his war against terrorist organizations.

3. Through the published issues, the European Union's interest in the nature of the relationship between the central government and the territorial government, the nature of the crises and the problems faced by the two parties during the past period is illustrated by the European Union's interest in Iraq's commitment to other countries.

4 - Al-Sabah tried to present to the public the nature of the American intervention in Iraq in its partial form, ignoring the truth, which is confirmed by all the media, Arab and international and even the American ones ... Here the newspaper has signed in the line of apparent contradiction.

5 - The newspaper presented the nature of the US support for the editing operations non-objectively through the issues published by the Secretariat on the aspect of air treatment and the provision of weapons.

6 - The newspaper tried to present the US policy in Iraq in support of the government policy and then support for the Kurds and here the newspaper signed in another contradiction with the existence of points of disagreement between the parties (the central government and the provincial government) in thorny issues have not been resolved so far

7 - The newspaper presented America's position on the policies of the regional countries towards Iraq in a selective manner that smelled of official and publicized policy of the countries when it was classified as a neighboring country that interferes greatly in the affairs of Iraq while the intention was to overlook the other parties.

8 - The newspaper supported the idea that America is working to coordinate with neighboring countries to improve relations between the parties and also seek calm, and this method aimed at improving the image of America, either the Iraqi public.

9 - The newspaper tried through the published topics to use some of the methods of satisfaction visible and invisible used by America to gain the individual Iraq, including investment and bank loans and the activity of international organizations and other charitable.

Recommendations

- The newspaper represents the official policy of the state, but it is possible to give the speech addressed to the public in a manner that does not overlook facts that can not be ignored by the public.
- The public can obtain information in many ways and here can not hide the facts or try to falsify or

neutralize and this is what the newspaper tried to present to the public.

3. The policy of the newspaper is appropriate to seek to achieve a balance between information and ideas according to current and future data and this is not found in the published topics.
