ABSTRACT

Three hundred and six books and articles published between 1919 and 1973 are listed in this bibliography covering Mexican Americans and bilingual bicultural education. It is divided into 3 major sections: (1) social sciences, (2) education, and (3) bibliographies. The works deal with history, sociology, anthropology, economics, linguistics, political science, law, mental health, educational psychology, methodology, teaching English as a second language, and modern language teaching.
