ABSTRACT

This annotated bibliography has been developed as a means of alerting ERIC users to recent commercially available publications in their fields. Titles have been selected in the basis of usefulness and general interest rather than very specialized technical reports for a restricted audience. All books chosen deal with some aspect of libraries, information science, media or educational technology, though not necessarily in an educational context. Citations are arranged in alphabetical order by author and a simple subject index lists titles under the headings of bibliographies, catalogs, directories, guides, and indexes; broadcasting and communications; cataloging and classification; computers; film, radio and television; how to do it; information management, models, and systems; instructional design and development; instructional media; libraries, librarians, and librarianship; miscellaneous; and school media programs and learning resource centers. A directory of publishers is appended.

Princeton, N.J.: Peterson's Guides (for the American Film Institute), 1978. 430p. \$9.75.

Reflecting the results of a detailed nationwide survey conducted by AFI's National Education Services division, this guide lists 1,075 schools teaching 9,216 courses in film and television, and provides course titles, faculty names, equipment and facilities available, academic degrees offered, admission requirements, financial aid availability, and curriculum emphases.

White Plains, N.Y.: Knowledge Industry Publications, 1978. 105p. \$24.50.

This report follows up a 1975 monograph on the same subject, and deals with the trends that have characterized significant changes in search services offered by libraries, e.g., more databases available, and lower online costs per search. Chapters deal with database producers, suppliers, and users; as well as background, development, problems, progress, and prospects.

Directory of Government Document Collections and Librarians, 1978. 2nd edition.

Cline, Nancy and Jaia Heymann, Co-editors.

Washington, D.C.: Congressional Information Service, 1978. 544p. \$22.50 (individuals must prepay).

Designed to bring together document users and document collections, this expanded directory lists nearly 2300 libraries in the U.S. with federal, state, local, foreign, and international documents holdings, and identifies 3600 people in the field.

The Relationship of the Library to Instructional Systems. Catholic Library Association Studies in Librarianship No. 2.

Corrigan, John T., C.F.X., Editor and Compiler.

Haverford, Pa.: Catholic Library Association, 1978. 58p. \$3.00.

The four papers in this booklet were delivered at the Relationship of the Library to Instructional Systems Institute, held during the 1977 CLA Convention, which was designed to assist librarians in relating the media center program to the school's instructional system through an exploration of the librarian's ability to apply the principles of learning and learning theory to informational objectives.

Implementing Individualised Learning in Schools and Colleges.

Davies, W.J.K.

London, England: Council for Educational Technology, 1978. 259p. 6.50 British pounds.

Intended to serve teachers as an introduction to the problems of initiating various forms of individualized instruction and possible solutions.

Access to Film Information: An Indexing and Retrieval System for the National Film Board of Canada. Occasional Paper 15.

Dykstra, Mary.

Halifax, Nova Scotia: Dalhousie University Libraries and Dalhousie University School of Library Service, 1977. 85p. \$3.50 (includes postage).

Based on an exploration of existing studies, systems, and practices in media information storage and retrieval, this revised and updated report seeks to cull from them those features which would be most likely to satisfy the needs of the National Film Board of Canada and its users.

The Economics of New Educational Media. Present Status of Research and Trends.

The state of the inventory begun by Unesco at its 17th session to define the role of new educational technologies in education systems and determine their cost-effectiveness is reported.

A programmed instruction unit teaching the principles of selection of main and added entries, to be used in conjunction with AACR I or II.

Metuchen, N.J.: Scarecrow Press, 1978. 57p. \$3.50.

A programmed instruction unit teaching the principles of selection of subject headings; examples apply to Sears and Library of Congress Subject Headings, but principles taught are generalizable.

Classification. 2nd edition. (Modern Library Practice Series).

Metuchen, N.J.: Scarecrow Press, 1978. 87p. \$3.50.

A programmed instruction unit teaching the basics of classification and Cuttering. Deals with Library of Congress and Dewey Decimal Classifications.

Construction and Adaptation of the Unit Card. 2nd edition. (Modern Library Practice Series).

Elrod, J. McRee.

Metuchen, N.J.: Scarecrow Press, 1978. 80p. \$3.50.

A programmed instruction unit that teaches a library technical services paraprofessional or library science student to type a unit card from a marked title page and to adapt it or a set of printed cards to make a full set of catalog cards.

Filing in the Public Catalog and Shelf List. 2nd edition. (Modern Library Practice Series).

Elrod, J. McRee.

Metuchen, N.J.: Scarecrow Press, 1978. 81p. \$3.50.

A programmed instruction unit designed for training inexperienced, non-professional technical processing workers to be able to arrange and file catalog and shelf list cards with a minimum of errors and with little supervision.

Federal Funds for Reading. NAVA Special Report.

Fairfax, Va.: National Audio-Visual Association, 1977. 86p. \$6.00 prepaid (include \$1.00 postage and handling if billed).

A NAVA special report about Federal government spending of nearly \$5 billion in support of 26 reading skills programs, which include pre-school through college learners as well as adult education and library support. Programs are presented, including the information necessary to apply for funds, particularly for audio-visual equipment and materials.

Evaluation of the CARIS Pilot Project.

The Current Agricultural Research Information System (CARIS) Pilot Project was begun in 1972 to collect and disseminate information on research establishments and their activities in plant and animal production, forestry, and inland fisheries. This report contains evaluation studies based upon the pilot project's input, processing, output, and future.

The Cost of Learning with Computers: The Report of the Financial Evaluation of the National Development Programme in Computer Assisted Learning.

A final report from a 4½ year project concerned with studying the financial and resource implications of more than thirty development projects in a range of education and training establishments.

Part of a Unesco series, this study deals with the analysis of communication policies--principles and norms established to guide the behavior of communication systems--on the public, institutional, and professional levels in Costa Rica.

Sex Role Stereotyping in the Mass Media. An Annotated Bibliography.

New York, N.Y.: Garland Publishing, 1977. 350p. \$25.00.

Brings together statistical research and empirical studies in an effort to demonstrate the pervasiveness of sex role stereotyping and the current struggle against it, and lists published and unpublished articles, pamphlets, speeches, and lectures available in print and non-print formats.

More Films Kids Like.

Chicago, Ill.: American Library Association, 1977. 168p. \$8.95 (paper).

A successor to the 1973 *Films Kids Like*, this volume annotates 200 films of general interest found to be the most successful, recently released, short 16mm films for children two to twelve years of age. Includes guidelines and suggestions for classroom use.

Introduction to Librarianship. 2nd edition.

Gates, Jean Key.

New York, N.Y.: Mc-Graw Hill Book Co., 1976. 302p. \$10.95.

Fundamental elements of librarianship, such as its history; professional organizations and library education; kinds of libraries and library objectives, needs, and services; and guides for professional performance, are set forth in sufficient detail to provide a body of basic literature for an introductory course.

Paperback Books for Young People: An Annotated Guide to Publishers and Distributors. 2nd edition.

This expanded and updated edition lists and describes all of the leading paperback publishers and distributors of titles for young people in the U.S. and Canada.

A basic selection tool compiled for use by librarians or others interested in stimulating children's interest in literature, which contains over 500 annotated listings of books, followed by listings of 16mm films, filmstrips, and recordings based upon the books, and author, subject, and media indexes.

Broadcast Journalism: An Introduction to News Writing. 2nd edition.

New York, N.Y.: Hastings House, 1978. 156p. \$7.95 (cloth), \$4.95 (paper).

A practical approach to radio and television news, covering basic news writing techniques and style, as well as information and guidelines in handling the major types of stories encountered, a journalist's rights and responsibilities, and the mini-documentary.

Multitype Library Cooperation.

Hamilton, Beth A. and William B. Ernst, Editors.

New York, N.Y.: R.R. Bowker, 1977. 216p. \$19.95, postpaid.

Essays by distinguished librarians on the philosophy, dynamics, and actual experiences of formal library cooperation among libraries focus on the purpose of the multitype library network: "to mobilize total library resources to meet the needs of the user...related to educational, work, and recreational needs."

Media Center Facilities Design.

Hannigan, Jane Anne and Glenn E. Estes, Editors and Compilers.

Chicago, Ill.: American Library Association, 1978. 138p. \$10.50.

This collection of works by school media center authorities describes architectural features, facilities, and equipment needed for an effective media center, and discusses the relationship between the educational program and the physical facilities.

Designed to bring together many concepts which will assist the library media specialist in presenting creative and innovative instructional activities, this book provides access to multimedia and other instructional resources such as games and simulations.

Metuchen, N.J.: Scarecrow Press, 1977. 295p. \$12.00.

Seventeen commissioned papers describe and assess significant recent progress in comparative and international library science subfields such as research, library education, media, bibliography, and various types of libraries.

Washington, D.C.: National Education Association, 1977. 151p. \$12.85 (cloth), \$8.75 (paper).

Designed to aid and encourage the development and improvement of libraries for teachers, this publication includes a guide for their establishment, with information on concept, scope, organization, administration, and selection; and selected bibliographies.

Television and the Teacher: A Handbook for Classroom Use.

Hilliard, Robert L. and Hyman H. Field.

New York, N.Y.: Hastings House, 1976. 94p. \$5.95.

Designed for use by teachers, administrators, and communications students, this handbook provides guidelines for and an overview of effective instructional television usage and evaluation.

Emerging Data Protection in Europe.

Hondius, Frits W.

Amsterdam, The Netherlands: North-Holland Publishing Co., 1975. 282p. \$27.75 (U.S.).

Describes the concept of "data protection," the legal rules and instruments designed to protect the rights, freedoms, and interests of individuals whose personal data are stored, processed, and disseminated by computers, and to protect them against alteration, loss, destruction, or disclosure. Contains information on data protection legislation in a number of European countries.

Economic Education: A Guide to Information Sources.

Hughes, Catherine A., Editor.

Detroit, Mich.: Gale Research Co., 1977. 274p. \$18.00.

Lists and describes a cross-section of the books and media available to teachers of economics for preschool through high school age students. Entries are arranged by sub-topic within the economics field, annotated, and indexed by author, title, audiovisuals, and subject.

From Cutter to MARC: Access to the Unit Record. Queens College Studies in Librarianship No. 1.

Hyman, Richard J.

Flushing, N.Y.: Queens College of the City University of New York, 1977. 48p. \$2.00.

Designed for librarians and students, this monograph traces the development of the unit-record concept on theory and practice, compares retrieval capabilities for the traditional unit record and the machine-readable record, and details possibilities for manual access to data in printed card and book catalogs.

Information Systems: Their Interconnection and Compatibility.

Vienna, Austria: International Atomic Energy Agency, 1975. 482p. \$28.00 (available from UNIPUB).

Proceedings of a symposium organized by the International Atomic Energy Agency and co-sponsored by the FAO and Unesco, designed to further international information exchange and system development, and to provide a forum for discussion about the problems encountered in matching various and different information systems.

UNIMARK: Universal MARC Format.

International Federation of Library Associations and Institutions.

London, England: IFLA International Office for UBC, 1977. 137p. \$15.00.

The IFLA Working Group on Content Designators prepared this document in response to a charge to investigate differences in content designators assigned to the data content of machine-readable bibliographic records, to explore how these differences could best be accommodated, and to arrive at a recommended standard for the international exchange of bibliographic data in machine-readable form. Scope was limited to library community requirements.

Modern Radio Station Practices. 2nd edition.

Johnson, Joseph S. and Kenneth K. Jones.

Belmont, Calif.: Wadsworth Publishing Co., 1978. 430p. \$12.95.

Designed to provide the beginning broadcaster or student with knowledge of programming in today's radio station from a management view, including both theoretical and practical information, with an expanded section on production.

Handbook of Black Librarianship.

Josey, E.J. and Ann Allen Shockley, Compilers and Editors.

Littleton, Colo.: Libraries Unlimited, 1977. 392p. \$17.50 (U.S. and Canada), \$21.00 (elsewhere).

Thirty-seven topical essays and resource lists are included in this handbook defining black Americans' contributions to American libraries in the past and present. Resources for African and Afro-American studies are also identified and described.

Library Lit. 8--The best of 1977.

Katz, Bill, Editor.

Metuchen, N.J.: Scarecrow Press, 1978. 339 p. \$12.00.

The eighth collection of the year's 30 best articles concerning subjects of current and continuing interest to the library profession, such as escalating journal prices, library management, and alternatives to user fees.

Reference and Information Services: A Reader.

Katz, Bill and Andrea Tarr, Editors.

Metuchen, N.J.: Scarecrow Press, 1978. 466 p. \$12.50.

This collection of 31 readings brings together a representative view of reference and information services as seen by working librarians and laypersons, and includes information on both theory and practice, as well as specific reference forms.

A collection of the standard and commonly used subjects applicable to Catholic, Jewish, and Protestant libraries, arranged in a single alphabetical listing with their corresponding Dewey Classification numbers and appropriate references.

Books on American Indians and Eskimos: A Selection Guide for Children and Young Adults.

Lass-Woodfin, Mary Jo, Editor.

Chicago, Ill.: American Library Association, 1978. 254p. \$20.00.

Includes annotated listings of more than 750 books, each describing some aspect of life of American Indians and Eskimos, with an emphasis on the information and insights available from the books cited. Reviews also include comments on possible uses, list strengths and weaknesses, estimate grade level, and provide a rating scale of good, adequate, or poor.

Deciding to Individualize Learning: A Study of the Process.

MacKenzie, Malcolm L., Compiler and Editor.

London, England: Council for Educational Technology, 1978. 84p. 2.25 British pounds.

These abstracts are based on three semi-structured taped interviews on the processes which led to the decision to gear the learning approach in the new Dundee College of Education to individualized learning and educational technology. It is intended to be read in conjunction with the extensive case study prepared by Mrs. Ann Lickley.

Children's Literature: Selected Essays and Bibliographies.

Selected for children's specialists who face the problems of keeping up with an ever-growing body of literature, these essays and bibliographies each focus on a topic in children's literature such as mental illness, drugs, alcoholism, science, and animals.

Guidelines or objectives for planning, reviewing, and evaluating library services to religious congregations, intended for use by administrators and church library committees.

The Celluloid Empire; A History of the American Movie Industry.

Stanley, Robert H.

New York, N.Y.: Hastings House, 1978. 328p. \$15.75 (\$7.95 paper).

Provides the reader with an informational frame of reference concerning America's movie industry: its origin, hierarchy, transition years during which movies became a major industry, censorship, and future directions.

State of the Art in Management Information Systems for Public Health/Community Health Agencies; Report of the Conference.
