ABSTRACT

Recently electronic journal became very important publication means, more than the normal journal sometimes, in accordance with the high speed of spreading out apart form geographic boundaries plus the ability to the others to take part and add their contributions easily. The electronic journal is as far as normal journal shouldn't injur individuals and their special freedom, and private rights, or the one who is injured could sue the electronic publisher for compensation.

In civil action against electronic publisher, the plaintiff should present convenient evidence, mostly electronic ones as far as the nature of suit and its topic.
